b) Contractors/firms desirous to take part in the tenders can also get themselves registered with Civil Mtc. Circle by sending their application to this office, at least 15 days prior to the last date of uploading of tender, along with DD of ₹1180/- (inclusive of GST) in favour of AO / O&M, GGSSTP, Ropar along with the requisite documents as mentioned below from sr. no. 2 to 11.

Experience:- Experience of having successfully completed/executing the civil work of similar nature (Similar work means work of Stoppage of water leakage from expansion joint of RCC duct etc) during last 7 years ending last day of month previous to the one in which applications are invited should be either of following:

a) One similar completed/being executed work costing not less than the amount equal ₹ 1.56 lac or

b) Two similar completed/being executed work each costing not less than the amount equal to ₹ 0.94 lac or

c) Three similar completed/being executed work each costing not less than the amount equal to ₹0.78 lac

The value of work done shall be considered on yearly basis.

3. Average annual turnover during last 3 years, ending 31 March 2020, should be at least ₹ 1.56 lacs.

4. **Bank solvency:-** Bank solvency certificate of minimum of ₹ 3.12 lacs shall be attached. Bank solvency certificate shall not be more than 12 months old.

5. **Balance sheet:-**Audited balance sheet for past three financial years shall be attached.


