SECTION-I

TERMS AND CONDITIONS

GENERAL, TERMS AND CONDITIONS:-

- RATES: Rate should be firm & inclusive of all taxes & duties and should be quoted FOR GGSSTP, Ropar & should be given in both figures and words. Corrections, Cutting etc. should be legibly signed or avoided. The quotation not having FOR destination rates is liable to be rejected.
- GOODS AND SERVICE TAX: PSPCL is registered centrally in the state under GSTIN 03AAFCP5120Q1ZC.
- GST, as applicable, will be paid as per prevailing provisions of GST Act & Laws against submission of documentary proof at rate(s) prevailing during the contracted delivery period on the basis of actual. The following certificates shall have to be furnished along with invoice —cum—gate pass duly signed by the authorized agent /signatory. The first invoice should accompany the specimen signatures of the authorized signatory duly attested by the Managing Director of the factory with a copy of orders regarding his appointment as authorized signatory.
- Certified that the transaction on which the GST is claimed has been/shall be included in the return submitted / to be submitted to the GST Authorities and the amount claimed from the Punjab State Power Corporation Ltd. has been / shall be paid to the GST Authorities.
- Certified that the goods on which GST has been charged have not been exempted under GST Act or rule made there under and that the GST charged on these goods is not more than what is payable under the provisions of relevant act.
- Certified that we shall indemnify the Punjab State Power Corporation Ltd. in case, it is found, at a later stage that wrong or incorrect payment had been received on account of GST; the same will be refunded.
- Certified that we are registered dealer under the GST Act and our Registration No.
- in case the GST is applicable and is required to be paid extra as referred to Para(i) above, the tenderer should clearly indicate HSN code of item along with present rate (in percentage) applicable to their company.
- The maximum rate (in percentage) up-to which the GST may become leviable/ payable under the prevailing Rules & Regulations applicable to their company, should also be clearly indicated in their tender.
- In case the GST is applicable /payable, necessary certificate of GST claimed / GST Gate Pass duly authenticated by the authorized representative of GST Authorities, shall however, be furnished by the supplier along with each consignment. The supplier should, therefore, clearly indicate in their tender that whether such GST Gate Passes/Certificates shall be furnished by them or not.

NOTE: The firms indicating nil or concessional rate of GST in their tenders (if any) will, have to absorb GST up to the full rate applicable at the time of tendering.

- FURTHER any loss due to non-availability of ITC or levy of penalty/ interest payable by PSPCL on account of non-filling of return or non-compliance or any miss-statement given under the provisions of GST ACT by the firms shall be recoverable from them.
- Further GST at applicable rates on principal supply shall be payable on Freight and Insurance.

- VALIDITY: All tenders must be valid for a period of at least 120 days from the date of opening of tenders.
- 4. PAYMENT: 100% after refilling and supply of fire extinguishers at GGSSTP site.
- 5. INCOMETAX: Income tax will be deducted as applicable from the contractor's' bill.

6. EARNEST MONEY:-

 The tenderer shall be required to submit earnest money as detailed in tender specification.

II.) Earnest money shall be forfeited in case of with drawl/modification of NIT/Tender specification after opening of tender.

III) In case of successful tenderers, Earnest money shall be converted as Security Deposit.

IV) The earnest money shall be refunded to the unsuccessful tenderers within 30 days of the award of order/Contract (LOI).

V) Tenders received without earnest money shall be rejected.

7. SECURITY:-

i.) The earnest money deposit at the time of tender shall be converted into security deposit and balance will be deducted from the bill to make the 5% of the gross value of work done.

ii.) No interest shall be payable to the firm on the amount of earnest money or security deposit.

iii) On faithful execution of work in all respects, the security deposit of the firm shall be refunded after the expiry of Warranty period of three years.

iv) In the event of default on the firm in the faithful execution of work order, the security deposit shall be forfeited. The forfeiture of security deposit shall be without prejudice to any other right arising or accruing to the PSPCL under relevant provisions of the work order like penalty for delay in delivery including suspension of business dealings with PSPCL for a specific period.

8. DELIVERY:-

ABC type fire extinguishers after refilling will be supplied at site maximum within 40 days of the receipt of work order alongwith test certificates of hydraulic testing as per Indian standards.

9. INSPECTION AND TEST:-

The PSPCL shall inspect and test the refilled fire extinguishers through representative of this office at the firms works during or after refilling of fire extinguishers prior to dispatch. The supplier shall provide facilities as may be required to carry out the test free of cost. Refilled Extinguishers inspected in two stages:-

 All the material required for refilling will be inspected after the inspection call for the same.

ii) ABC type fire extinguishers will be inspected after refilling and providing of all the necessary fitments as per scope of work. The firm shall supply valid test certificates after hydraulic testing of the Fire extinguishers

10. WARRANTY:-

Equipment/material should be warranted for three years of satisfactory operation after refilling. During the warranted period of three years if any leakage occurs it shall be rectified by the firm free of cost failing which the security of firm shall be forfeited.

11. PENALTY FOR DELAY IN EXECUTION OF WORK: -

If the firm fails to complete the job with in stipulated completion period of the work order, the same is liable to pay as penalty charges @ 0.5% per day of the total quoted amount subject to the maximum of 10%.

12. EXTENTION OF TIME: -

If the firm shall desire an extension of the time limit for completion of the work on ground of his having been unavoidably hindered in execution or on any other ground, shall apply in writing to the authority placing work order and competent authority may if in his opinion, there are reasonable grounds for granting extension, allow such extension as he thinks necessary or proper. The decision of the competent authority in this regard shall be the final and binding.

13. INSURANCE AGAINST LOSSES/ DAMAGES: -

The rates are required to be quoted on FOR destination basis and it is the responsibility of the firm to deliver the goods in sound conditions upto GGSSTP and also during installation, testing & commissioning of the tank at site. For this purpose the firm may at its option insure the material against all risks/ losses/ damages at its own cost during transit of the material, at its works and also at GGSSTP site during installation testing & commissioning of the tank. Such losses/ damages will have to be made good by the firm free of cost immediately without waiting for maturing of their claims with the Roads Transport / Railway authorities or any other agency so involved.

14. SIGNING OF CONTRACT: -

In the event of tender being accepted, intimation shall be given to the contractor, who shall there upon attend office of the accepting authority to execute the contract agreement.

15. SCOPE OF SUPPLIES BY GGSSTP (FREE OF COST): -

ABC cylinders of 5Kg. Capacity make Ceasefire with all fitments either in good condition or defective.

16. GENERAL: -

- Empty ABC fire extinguishers shall be collected by tenderer from GGSSTP site after submitting the Indemnity Bond and return the same after refilling at his own cost.
- ii) Firms representative may visit the site to get familiarized with every detail of the work involved before quoting the rates since there may be minor variations to suit the site conditions.
