**Terms and conditions:-**

1. Vehicle should not be more than 4 years old at the time of hiring the vehicle. Vehicle as per above make & model and registered as taxi on his/her/Firm's name shall be hired. Vehicle must have RC with yellow name plate entry on it. If yellow plate not provided by the firm then his EMD will be forfeited and the firm will be blacklisted.
2. In addition Hiring of Honda City/Maruti Ciaz or equivalent vehicle with driver or Toyota Etios/ Maruti Suzuki/ Breeza or equivalent vehicle with driver for official use of Chief Engineer/ GGSSTP, Rupnagar are also acceptable.

4. **ELIGIBILITY CONDITIONS:**

- i. The tenderer should have minimum 1 No. Honda City/Maruti Ciaz or equivalent vehicle with driver OR 1 No. Toyota Etios/ Maruti Suzuki/ Breeza or equivalent vehicle with driver for official use of Chief Engineer/ GGSSTP, Rupnagar.
- ii. They should submit orders for execution of work related to providing any type of out-sourced vehicle for the purpose of transportation in PSPCL/PWD/Railways/MES /Mandi board or any other govt/ semi Govt. depts./Pvt. industry to show their capability.
- iii. They should not be blacklisted by any Govt./Public Sector Utility during last three years. A self-attested undertaking will be furnished by them in this regard.
- iv. Tenderer should have the vehicle registered on his/her/firm's name.
- v. Photocopies of valid Driving License of Driver must be supplied.
- vi. Photocopy of the Insurance copy of vehicle must be supplied.
- vii. Copy of valid PAN issued by Income tax department must be supplied.
- viii. Copy of GST registration must be supplied.
- ix. Copies of registration certificate must be supplied.
- x. They should have independent EPF & ESI account no. issue from concerned department
