

- 4) Telegraphic / Fax/e-mail quotations shall not be accepted.
- 5) Negotiations shall not be held excepting with the lowest tenderer.

Terms & conditions:

- 1) The tender documents can be purchased from the office of SE/Monitoring, GGSSTP Rupnagar by depositing tender fees of Rs.500 plus GST@18% (non-refundable) in form of DD in favour of Account Officer, O&M , GGSSTP payable at Rupnagar or BA-16 receipt, otherwise the quotation of the firm will not be considered.
- 2) **PQR:** - Tenders will be issued to only those firms which have valid approval from Petroleum and explosives safety organization (peso), Government of India, for testing of hydrogen gas cylinders. The firm will submit the documentary proof of the same.
- 3) The tender must be valid for at least 120 days from the date of opening of tenders
- 4) Tender shall be submitted in duplicate. The tender shall be in two separate envelopes, one envelope containing the main tender and the other containing the earnest money. Both the envelopes should be clearly marked with 'EMD' & 'MAIN TENDER'. While opening the tender, the envelope containing Earnest Money shall be opened first. In case the deposit of Earnest money is not as per clause 12, then the main tender shall not be opened and the tender shall be treated as invalid.
- 5) Quotation/Tender should be enclosed in double cover both addressed to SE/Monitoring, GGSSTP P.O. Ghanauli ,Rupnagar, Pin No. 140113 Punjab. Both inner & outer covers shall be sealed and super scribed with Tender Enquiry No. as given on the enquiry/Tender Notice together with the date on which the tender opening is due and the name of work.
- 6) **Period of contract:** - The firm will test the cylinders in two lots of 96 cylinders & 94 cylinders each respectively. The firm will complete the work within 45 days from the date of handing over the Hydrogen gas cylinders for testing from the Engineer-in-Charge , for each lot of cylinders.
- 7) Tender received through telegraph, telex, fax or e-mail shall not be considered.
- 8) Chief Engineer/GGSSTP, Ropar reserves the right to refuse issue of tender Documents to any contractor/ firm without assigning any reason & also to reject any or all offers without assigning any reason and no claim on this account will be accepted.
- 9) The firm shall have an independent EPF, ESI code number, PAN, GST number, issued from the concerned authority.
- 10) The contract can be terminated after giving 15 days notice by Engineer-In-Charge of PSPCL without any additional liability to PSPCL without assigning any reasons, whatsoever.
- 11) The firm should have independent GST No. and will submit a copy of the same.
Firm will provide following certificate:
 - Certified that the transaction on which GST is claimed has been/shall be included in the return submitted / to be submitted under GST law and the



amount claimed from PSPCL has been deposited/shall be deposited with GST authorities.

- Certified that the supplies on which GST has been charged have not been exempted under GST Act or rule made there under and that GST charged on these supplies is not more than what is payable under the provisions of relevant act.
 - Certified that we shall indemnify the PSPCL, in case, it is found at a later stage that wrong or incorrect payment has been received on account of GST; the same will be refunded.
 - Certify that we are registered under GST Act and our registration no. is ~~1234~~

- Further any loss due to non-availability of ITC or levy of penalty/interest payable by PSPCL on account of non-filing of return or non-compliance or any miss-statement given under the provisions of GST Act by the contractor shall be recoverable from them.

12) The tenderers shall be required to submit earnest money in the form of PSPCL Cash Receipt/Bank Draft in favour of AO/O&M GGSSTP, PSPCL Ropar (Payable at Ropar) along with the Tender as per Rules & Regulations of the PSPCL & as per rates given below:

a) Tender valuing up to Rs. 50,000/-: Nil
and Spot Tender

b) Tender valuing above Rs.50, 000/- : 2% of tender value rounded other than spot tender rounded off to a multiple of Rs.10 on the higher side. Subject to a minimum of Rs.5000/- and maximum of Rs. 10.00 Lac.

Public Sector Undertakings owned by Pb. Govt./Central Govt./Other State Govts. Shall be exempted from depositing Earnest money subject to submission of documentary evidence of Government ownership. The certificate of shall be submitted in the envelope of Earnest money. Exemption shall not be applicable if the Tender is submitted for supply of material through private unit/manufacturer.

13) In case of any dispute regarding issue of tender documents or any other dispute, CE/O&M, GGSSTP Ropar shall be the final authority and no claim on this account shall be accepted.

14) In case the date of opening of tenders happens to be holiday, the tenders will be received and opened on the next working day at the same time and place.

15) The rates should be quoted as per reference Performa.

16) Pricing Schedule must be clearly typed and hand written prices shall not be accepted.

17) Any deviation in technical and General conditions must be clearly mentioned separately. Otherwise, it would be assumed that the offer is entirely as per enclosed technical specifications and general conditions and the same are acceptable to the tenderer.

18) The tenderers revising their offer or withdrawing the same within the validity period after opening of the tenders are liable to be ignored/ black listed

19. i) Firm should mention GST registration no. in quotation/offer. If the firm is registered under COMPOSITE LEVIES then the same should be clearly mentioned in quotation.

ii) The firm must provide HSN/SAC code in price schedule Performa.

iii) Tax rate as provided in quotation shall be final.

20) Negotiations if any will not be held except with the lowest tenderer (L-1).

21) Supply the recent copies of WO's placed by other states in your firm for the same items in justification of quoted rates


22) Bid should be submitted in two parts.


