Hiring of outsourced vehicle on contract basis for one year for the use of office of Addl. SE Enforcement cum EA & MMTS, Barnala. Tender Notice/ Enquiry no. 01/ENF/2023-24/PSPCL/BARNALA dated 30.06.2023 in this tender document Clause no. 9 i.e. Period of Contract of Other Terms & Conditions/Specifications, Amended (as per Corporate transport policy of PSPCL issued by Dy.CE.Personnel, PSPCL Patiala vide memo no. 23851/950/GB/V-612 dated 11/07/2023).

The work order for out-sourcing of vehicles, for the vehicles not more than 5 years old, shall be initially for a period of one year and the same shall be extendable on year to year basis for a further period of three years, on the satisfactory performance of the vehicle/service provider subject to condition that the vehicle can continue in the department up to the 7 years of its life. Hence the maximum period for which a vehicle can be hired is 4 years. After a period of 4 years, a new tender needs to be floated.

All other terms and conditions of enquiry will remain unaltered.
