**TERMS & CONDITIONS:**
**1. ELIGIBILITY CRITERIA:**

The following firms will be eligible as tenderer for this work:

- Tenderer who have been authorized by the department of explosives under ministry of commerce & industry Govt. of India for testing of the gas cylinders. The tenderer shall furnish the valid authority letter for the same and

- b. Should have executed the same job for any Govt. /semi Govt./Private utility and shall supply the copies of the work orders & performance certificate thereof for the works carried out during last seven years.
2. The firm/contractor may deposit cost of tender documents amounting to Rs. 500/- (Rupees Five Hundred only non -refundable) plus GST as applicable (Present rate is 18%) i.e. total cost of tender documents is Rs. 590/-. Tenders of the firms/contractor which do not deposit the cost of specifications before or by the last date and time of bid submission shall not be accepted. **The cost of tender specifications must be deposited electronically/online only on website <https://eproc.punjab.gov.in> before or by the last date and time of bid submission.**
  3. All tenderers have to deposit Earnest Money at the rates prescribed in the tender documents as per **Clause (6) of Tender specifications** except in case of those tenderers who are specifically exempted there-under. Tenders without or having insufficient earnest money shall not be considered /accepted. **The EMD must be deposited electronically/ online only on the website <https://eproc.punjab.gov.in> before or by the last date and time of bid submission.**
  4. The rates should be quoted as per reference Performa for quoting rates. The rates quoted must be valid for a period of at least 120 days from the **date of opening of the tenders.**
  5. **Bidders have to submit Techno-commercial/Price bid in Electronic format only on website <https://eproc.punjab.gov.in> by the last due date & time for bid submission.**
  6. The rates quoted should be firm by taking in to account all levies, taxes (except GST).
  7. Tender received telegraphically, through fax, through telex or e-mail shall not be considered.
  8. The price bid shall be opened after satisfying that the tenderer is qualifying the pre-qualification conditions prescribed in the tender specifications. The date of opening of price bid and reverse auction shall be intimated later on to the qualifying bidders.
  9. **COMPLETION PERIOD:**
    - a) The testing of cylinders shall be completed by the firm with 35 days from the date of lifting of cylinders from GHTP site. In case of failure of the firm to complete the job within delivery period, firm shall be liable to pay as penalty charges a sum of Rs. 0.5% (half of one percent) of cost of work per day. In case the firm fails to report at site in time or does not execute the job assigned to it PSPCL shall have the discretion to get the job executed from some other agency at the risk and cost of firm.
    - b) The successful bidder shall lift the cylinders for testing within 7 days from date of intimation by this office.
  10. Conditional, late or incomplete tenders shall not be accepted.
  11. PSPCL/GHTP, Lehra Mohabbat reserves the right to reject any or all the offers without assigning any reason and no claim on this account will be accepted.
  12. In case of any dispute regarding issue of tender documents or any other dispute, Chief Engineer, O&M, GHTP, Lehra Mohabbat shall be the final authority and no claim on this account shall be accepted.
  13. Tenders shall be signed by the owner or person holding power of attorney by him to do so. Necessary documents in support thereof should be enclosed with the bid at the time of submission, falling which tender will not be considered.
  14. Bid should be submitted in three parts.


