### **TERMS AND CONDITIONS:**

- The firms may download tender specifications after paying the requisite tender document fee electronically i.e. Rs.500/- (non-refundable) plus GST (as applicable) from PSPCL Website <https://eproc.punjab.gov.in>.

Tenders of only those firms/contractor will be considered who are registered with GGSSTP/GHTP/NTPC or other such central government organizations for the jobs of rewinding of stator/ rotor by using Class 'H' insulation winding material, Dr. Beck make Elmoluft F-50 varnish, Sleeves, Glass threads, PGMA tapes, Epoxy slot wedges etc., Baking in oven at specified temperature, Gel coating, Testing and Painting of 220V DC motors and 415 V AC Slip ring motors, three phase, 415 V AC squirrel cage motors (Above 50KW rating) and three phase, 415 V AC submersible pump motors/ special motors of 45HP and Above of assorted ratings and/or Electrical motors of 415 V and 6.6 KV or above in Power Plant or at any other heavy Industry like Electrical /Pharmaceutical /Refinery/Petrochemical/ Steel Industry during the last seven year ending on (last date of month previous to one, in which tender are invited) having minimum contract value of either of the following. Those firms, whose performance against the works/contract executed/being executed at GGSSTP/ GHTP/during last 7 year is found to be unsatisfactory (by the competent authority) will not be considered for registration.

### **2. FOLLOWING FIRMS SHALL BE ELIGIBLE FOR REGISTRATION:-**

The firms desirous of registration will have to submit application for registration along with requisite fee and following documents:-

- Proof of having successfully executed jobs as per description of work in any one year during the last 7 years ending 30-06-2023 (date to be mentioned as last day of month previous to the one in which enquiry is floated) of minimum total value of either of the following :
  - One same/ similar completed/being executing work, costing not less than 7.5 lacs (the amount equal to 50% of the estimated cost) of any rating.
  - Two same/ similar completed/being executing work, each costing not less than 4.5lacs (the amount equal to 30% of the estimated cost) of any rating.
  - Three same/similar completed/being executed works, each costing not less than 3.75 lacs (the amount equal to 25% of the estimated cost) of any rating.

**Note:-** In case any firm is having on going yearly contract but has executed for lesser period than one year on 31.03.2023 then in that case it will be considered as one work .

- B. Proof of having average annual turnover during the last three financial years ending 31-03-2023 should be at least Rs. 7.5 lacs (50% of estimated cost).
- C. Bank solvency certificate of minimum value of Rs. 4.5 lacs (30% of estimated cost) issued by any scheduled bank should be submitted. Bank Solvency certificate should not be more than 12 months old.
- D. Copy of PAN Card as proof of having PAN No.
- E. Proof of having GST number.
- F. A self attested undertaking that the firm has not been blacklisted by any govt. /public sector undertaking during the last five years.
- G. Details of plant, equipment, machinery available with bidder in working order for carrying out the work shall be submitted to assess the capability of bidder.
- H. Further the contractor registered with NTPC and other such central govt. organizations will be considered eligible for participation, on submission of valid registration certificate. However contractors/ firms shall have to fulfill other Tender specifications / NIT clauses. The registration shall be valid for two years.
- I. Firm's who have valid registration need not required to re-register themselves again, however all other firm's have to re-register themselves for this work

The application for registration must be accompanied with non-refundable registration fee of Rs. 1,000/- (Rs. One Thousand Only) plus GST as applicable (Present rate is 18%) Total Rs. 1180/- in the form of PSPCL Cash Receipt or Bank Draft in favour of AO/O&M, GHTP, Lehra Mohabbat payable at State Bank of India (IFSC Code No. SBIN0050840), GHTP, Lehra Mohabbat or at any other scheduled Bank payable at Rampura Phul, Distt.- Bathinda.

- 3. After registration the firm will become eligible for participating in tender and may purchase the tender documents by submitting fees of Rs. 500/- Plus GST as applicable (Presently total Rs. 590/- with GST @ 18% to be deposited electronically) on PSPCL website <https://eproc.punjab.gov.in>.
- 4. All tenders must be accompanied by the Earnest Money at the rates prescribed in the tender documents except in case of those tenderers who are specifically exempted there-under. Tenders with insufficient earnest money shall not be considered/ accepted.
- 5. The rates should be quoted as per reference performa (Section-VII). The rates quoted must be valid for a period of at least 120 days from the date of opening of tenders.
- 6. The rates quoted should be firm and inclusive of all levies, taxes (except GST). Applicability of GST may be mentioned clearly by the bidder.

However, the firm cannot claim extension as a matter of right. However PSPCL reserves the right to short close the work due to any reason what so ever.

15. Conditional, late or incomplete tenders shall not be accepted.

17. In case last date of registration, request for registration, bid opening date falls on a holiday, the next working day shall be applicable. Online bid submission date will not change.
18. In case of any dispute regarding this tender, General Manager/Chief Engineer, O&M/Chief Engineer, GHTP, Lehra Mohabbat shall be the final authority and no claim on this account shall be accepted.
19. Tenders shall be signed by the owner or person holding power of attorney by him to do so. Necessary documents in support thereof should be enclosed with bid at the time of submission, failing which tender will not be considered.
