TERMS AND CONDITIONS:

- 1. The contractor shall have to purchase tender documents from the office of SE/Montg, GGSSTP Rupnagar on payment of Rs. 1000 /- (+ GST extra) towards the cost of each tender documents by BA-16 cash receipt issued by AO/O&M, GGSSTP, Ropar or through demand draft drawn in favour of AO/O&M, GGSSTP, Ropar payable at Ropar.
- 2. a) The contract shall be valid for one year and shall be further extendable for another 3 months with the approval of competent authority at the same rates and terms & conditions at the discretion of PSPCL subject to satisfactory performance of the firm/ contractor and shall be binding on the firm. If the date of the completion of work order falls in between shutdown of any / units then the completion period / date of work order shall be extended(even beyond fifteen months) up to stabilization of unit/ units at the discretion of GGSSTP/ PSPCL and shall be binding on the firm. The firm cannot claim extension as a matter of right.
  - b) The quoted rates should remain "FIRM" throughout the contract period and extended period (if any). It should be inclusive of statutory benefits payable to the workers deployed by the contractor as per various labour laws and all taxes and levies but excluding GST which shall be reimbursed as per clause-24 of specific Terms and conditions to govern the contract.
- 3. Pre Qualification Requirements (PQRs) for tendrers:

The tenderer must meet with all the below listed requirements to be eligible for participation in the bidding process:-

#### A) Registration:

I, tenders of only those technically suitable firms/contractors shall be considered who are registered with PSPCL/NTPC and other such government organizations for the work of Annual Overhauling of motorized & pneumatic operated valves & Gear Box under Electrical control or Instrumentation cell of 110MW or higher capacity power plants/ Pharmaceutical/ Refinery/Petro Chemical Industry.





II. Those firms whose performance against the works/contracts executed/being executed at GGSSTP during last seven years is found to be unsatisfactory will

not be considered for registration.

III. The firms already registered either for same job or registered for Assistant in Routine Breakdown/Preventive/Outage mtc. works of Motorized & Pneumatic operated valves and Gear boxes along with associated Electrical/Pneumatic Actuators of 4x210 MW GGSSTP units, Rupnagar with the office of Dy. CE/IMC and having valid registration on the date of bid submission need not to apply afresh.

However, firm will have to submit a copy of work order for Annual overhauling

work alongwith tender to access the firm's technical ability.

IV. The firms having valid registration with NTPC and other such central government organizations will have to meet the criteria of PQR to be eligible for this tender and submit the copies of all the relevant documents.

V. Experience of job either in electrical control or instrumentation cell weather Private Public/Govt. Power utilities of same nature shall be considered for

registration.

VI. Firm having experience of High pressure steam pipe lines and valves either in electrical control or instrumentation cell or Turbine or boiler weather Private Public/Govt. Power utilities of same nature shall be considered for registration.

VII. The registration of the firm/contractor shall be done on merit on the basis of

credential of the firm with the approval of competent authority.

VIII. Tenders of only those firms shall be considered if the registration of the firm is

done on or before the last date of receipt of tender.

IX. Firms can get themselves registered with GGSSTP by submitting documentary evidence fulfilling PQR,s along with non-refundable registration fee of Rs. 1,000/- (Rs. B) Technical ability, experience and past performance:-

The firm should have experience of executing successfully the work of Annual Overhauling of motorized & pneumatic operated valves & Gear Box under Electrical control & Instrumentation of 110MW or higher capacity power plants/Pharmaceutical/Refinery/Petro Chemical Industry during last 7 years ending last day of the month previous to the one in which application are invited should be either of the following:-

 One same/similar work costing amount not less than the amount equal to Rs. 1.13 lacs each.

OR

ii) Two same/similar work costing amount not less than the amount equal to Rs. 0.7 lacs each.

OR

- iii) Three same/similar work costing amount not less than the amount equal to Rs. 0.6 lacs each.
- C) Financial soundness.

 Average annual financial turnover during the last 3 years, ending 31<sup>st</sup> March of the previous financial year, should be at least Rs 1 lacs.

ii) Bank Solvency: Bank solvency certificate of minimum amount of Rs. 2 lacs must be submitted. The certificate should not be more than twelve months old.

iii) Balance Sheet: Copies of Audited balance sheets for past three financial years shall be submitted.

D) Compliance to statutory Laws:-

- Proof of independent EPF account number issued from regional Provident fund commissioner/Assistant Provident fund commissioner. EPF clearance certificate for the last financial year or proof of EPF deposits for the last 2 years are required.
- ii. Proof of having ESIC code number.
- iii. Copy of valid/ active PAN No.
- iv. Proof of having GST registration numbers.
- E) Affidavit:An affidavit in original duly attested by an Executive Magistrate/ Notary Public to
  the effect that:
- a. That firm is not a defaulter in respect of deposition of EPF/ ESIC to the concerned EPF/ ESI departments for the worker deployed against work orders placed by PSPCL or any other organization on it during last five years. In any case, the responsibility for deposition of EPF/ ESIC of the workers engaged by the firm shall rest with the firm only. In case, the firm is found defaulter at any stage in this regard, the contract shall be cancelled without any notice.

b. That the firm has not been black listed by any Govt./ Public Sector undertaking during the last five years.

- Age limit for workmen to be employed by the contractor shall be 18 to 62 years.
- GGSSTP reserves the right to allot whole or part of the work to any tenders without assigning any reason
- Complete details of the specifications are attached herewith.
- The Performa for price schedule enclosed with tender shall be filled by the tenderer which is attached as Annexure-A of tender specifications.
- 8. The tender must be valid for at least 120 days from the date of opening of tenders.
- 9. Tenders received telegraphically, through E-mail, telex or fax shall not be accepted.
- If the due date happens to be holiday, tenders shall be received and opened on the next working day at the same time.
- 11. The firm shall comply with all the regulations and acts framed by central/state govt. like ESI act 1948, Punjab Labour Welfare Fund (Amendment) Act, 2005, Payment of Bonus (Amendment) Act 2015, Factory Act 1948, Punjab Factory rules 1952 and other applicable labour enactments framed from time to time.
- 12. The firm will have to obtain license under Contract Labour (Regulation and Abolition Act-1970) before undertaking the work and shall comply by various provisions/rules framed there under.
- 13. The firm shall follow the Rules and Regulations of Employees State Insurance Act. 1948 as amended from time to time and shall have to obtain ESI number from the concerned office and shall keep PSPCL free from any liability arising at any stage.
- 14. The firm will deposit the requisite amounts as per Punjab Labour Welfare Fund (Amendment) Act, 2005.
- Tenders of contractors who are black listed or with whom business dealings are suspended by PSPCL will be rejected.
