

2. The tender documents will be issued preferably to those Co-operative Labour & Const. Societies who are registered with Registrar / Assistant Registrar Co-op. Societies as given in the Schedule "A" above.
3. The Societies / Contractors should have registered EPF Number, Pan Number, GST Number and they will produce documentary proof thereof.
4. The Societies / Contractors will quote their % above /below or at Par with respect to departmental rates on the prescribed price bid prepared by this office. The percentage quoted by the contractor should be exclusive of GST.
5. The competent authority reserves the right to reject any or all the tenders received

- without assigning any reason what so ever.
6. Conditional tenders and tenders received telegraphically / Fax / Telex and tenders which are not on the prescribed form issued by this office shall not be accepted.
  7. If due date of opening of the tender happened to be the holiday, the tender will be opened on next working day at the same time.
  8. Terms & conditions given in the schedule C (Section I to IV) of PSEB Work regulations 1997 with latest amendments shall be strictly adhered by the contractor.
