**TERMS AND CONDITIONS:**

- 1 Tenders of those bidders who have purchased the tender documents/specifications shall only be opened.
- 2 PQR:
  - A) Tenders of only those technically suitable firm /contractor will be considered who are registered with PSPCL/PSTCL, NTPC and other such state/central Govt. organizations (on submission of valid registration certificate) for the jobs of:-  
 "Breakdown/Preventive Mtc. & Overhauling jobs of DM Plant/Water Treatment Plant" AND/OR "Erection/ fabrication/ replacement/ rubber lining/ repair/ laying/ fitting of tanks/ pressure vessels/ pipe lines or similar jobs"
  - B) The firm should have proof of having successfully completed/being executed the jobs of:  
 "Breakdown/Preventive Mtc. & Overhauling jobs of DM Plant/Water Treatment Plant" AND/OR "Erection/ fabrication/ replacement/ rubber lining/ repair/ laying/ fitting of tanks/ pressure vessels/ pipe lines or similar jobs" at Thermal/ Nuclear/ Gas power plants or any other heavy industries like Petrochemical Plants, Cement manufacturing plant, Fertilizer Plant, Pharmaceutical Plant during last 7 years ending 30-04-2022 either of following:-

OR

OR
- c) One same work as above costing (including all taxes) not less than Rs. 1,74,000/- each


Those tenderers who consider themselves eligible for participation can get themselves registered with GGSSTP by submitting the attested copies of followings documents along with non-refundable registration fee of Rs. 1000/-+ GST@18% (Rs. - i) Copies of work orders and completion certificates for experience as per PQR.
  - ii) Copies of Audited balance sheets over during the last three financial years, ending 31<sup>st</sup> March of previous financial year.
  - iii) Bank solvency of minimum Rs. 3,48,000/-. Bank solvency certificate should not be more than 12 months old. Average annual financial turn over during the last three year, ending March of the previous financial year, should be at least Rs. 1,74,000/-.
  - iv) Proof of PAN and Proof of Goods and service tax (GST) registration number.
  - v) Proof of independent EPF account number.
  - vi) EPF clearance certificate: EPF clearance certificate for last financial year needs to be obtained. In the event of non-availability of clearance certificate proof of deposit of EPF for last two years shall be required.
  - vii) Proof of having ESI Code number.
  - viii) An Affidavit in original dully attested by an Executive Magistrate/Notary to the effect that
    - a) The firm is not defaulter in respect of deposition of EPF/ESI to the concerned EPF/ESI department for workers deployed against work orders placed by PSPCL or any other organization on it during last five years. In any case, the responsibility for deposition of EPF/ESI of workers engaged by the firm shall rest with the firm only. In case firm is found defaulter at any stage in this regard, the contract shall be cancelled without any notice.
    - b) That the firm has not been black listed by any government/public sector undertaking during the last 5 years.
4. **EMD:** - The tenderers shall be required to submit earnest money of **Rs 7,000/- ( Rs. Seven ThousandOnly)**, through demand draft in favour of AO/GGSSTP, PSPCL, Ropar payable at Ropar. *Public sector undertakings fully owned by Punjab Government/center Government/ Other state Government shall be exempted from depositing earnest money, provided that the certificate of Government ownership shall be submitted in envelope for Earnest Money.*
5. The firm shall have an independent EPF code number issued from the concerned RPFC authority.
6. The firm shall have to obtain license under Contract Labour Regulation and Abolition Act-1970 before undertaking the work and shall abide by various provisions/rules framed there under.
7. The firm shall have valid GST no. and are registered with the concerned Department.
8. The firm shall comply with all the regulations of ESI act, amended for time to time and shall keep PSPCL free from any liability arising at any stage.
9. CE/O&M GGSSTP Rupnagar reserves the right to refuse issue of tender documents to any contractor/ firm without assigning any reason and also to reject any or all offers without assigning any reason and no claim on this account will be accepted.
10. Tenders received through telegraph, telex, fax or e-mail shall not be considered at all.
11. In case the date of opening of tenders happens to be a holiday, the tenders will be received and opened on the next working day at the same time and place.

## SCOPE OF WORK

**Subject: Repair of Alkali Storage Tank, Stage-II DM Plant GGSSTP**

1. Firm will cut upper half portion of Alkali Storage Tank, except Dish-ends. Welding/machining/re-conditioning/Preparation of surface by sand blasting/burning/ chipping work shall also be in firm's scope.
2. Transportation (To and Fro) of Tank, if required, will be in firm's scope.
3. Firm will arrange at its own MS Sheet 10 mm thick. Welding electrode, cutting gas, nut-bolt and all other consumables/non-consumable material required for the entire job will be arranged by the firm
4. The firm will arrange all the T&P required for work.
5. Firm will bend/mould/cut MS sheet (10 mm thick) and after giving proper shape firm will intimate Engineer-in-charge about readiness of structure. **Only after clearance and through checking by Engineer-in-charge firm will start welding work.** During checking Engineer-in-charge may ask for the proof of purchase of MS Sheet 10 mm and firm will produce the same.
6. Joining of MS sheets by welding double layer will be done after making "V" with grinder from both sides of tank i.e. inner and outer.
7. Providing 02 Nos. manholes, nipples, valves, gauge glass fittings, gauge glass etc all will be in firm's scope. Firm will also provide collars on outer surface of tank as already provided. For reference firm may note all these accessories from already installed Alkali Storage Tank at DM Plant Stage-II.
8. After completion of welding work, firm will apply one coat of epoxy red oxide zinc chromate primer and then two coats of black epoxy paint on entire inner surface of tank. Likewise firm will apply one coat of zinc phosphate primer & then two coats of white chlorinated rubber paint on entire outer surface of Alkali tank. Firm shall intimate Engineer-in-charge before painting the surface. **Only after checking the material by Engineer-in-charge firm shall start painting job.** Paints/primers should only be Asian/ Burger/ Narolac make only, no equivalent or other brand is acceptable. During checking Engineer-in-charge may ask for the proof of purchase of Primer/paints and firm will produce the same.
9. In case during fitting of Acid storage tank any damage is made to foundation, then firm will set right it as per actual with no extra cost.
10. During fitting of tank if any extra support/ modification/packing is required for foundation where the tank will rest, then firm will provide the same with no extra cost.
11. After installation of tank in GGSSTP, firm will also install same iron ladder and platform as it is, as already provided.
12. Any other work required for completion of the job as decided by Engineer-in-charge will be in the scope of the firm.
13. Minor repair of dis-ends if needed, as decided by Engineer-in charge, shall be done by firm.

### Scope of Supply by Contractor

- A) The firm shall arrange its own tools & tackles/T&P required for cutting, grinding, welding set & welding lead etc., lowering and lifting/shifting of Tank.
- B) The firm shall provide Labour and supervision with adequate knowledge and skill to carry out the jobs to the entire satisfaction of PSPCL.
- C) Welding electrodes of good quality grinding wheels, emery paper, Nut-bolts, Thimbles, D.A. gas, Oxygen gas etc. required for work shall also be arranged by the firm.
- D) Any other consumable required for the entire scheme shall be in the scope of the firm/Contractor.
- E) **Dismantled material shall be board's property and it shall be transported or returned to PSPCL store by firm/Contractor.**
- F) Contractor will arrange its own Tractor-trolley.

### PSPCL's Scope

- a. Available compressed air, water, electricity and space for storing the material shall be provided by PSPCL while carrying out the job at GGSSTP site free of cost. Also, electrical hoists/ cranes wherever installed shall be provided free of cost, subject to its availability.
- b. Accommodation, if available shall be provided to the Company Engineer/ Supervisor/ Workers in GGSSTP Field Hostel / Subordinate Rest House on payment basis.
- c. Hydra-crane, if available, may be provided to Contractor/firm for installation/dismantlement of Tank only.
