### Terms & Conditions:-

1. The tender document shall be opened only to those who have valid registration certificate issued by any state/central government department/PSU with registration limit minimum up to cost of work and have satisfactorily executed similar work during the last three years.
  - a. Three similar completed works costing not less than the amount equal to 40 % of the estimated cost i.e. Rs. 1.17 Lacs.
  - OR
  - b. Two similar completed works costing not less than the amount equal to 50% of the estimated cost i.e. Rs.1.46 Lacs.
  - OR
  - c. One similar completed works costing not less than the amount equal to 80% of the estimated cost i.e. Rs.2.33 Lacs.

Similar nature of work means construction/repair/renovation of buildings, roads, towers and other allied civil works.
2. All tenders must be accompanied by earnest money at the rates of 2% of the tendered value rounded off to a multiple of Rs. 10/- on the higher side subject to minimum of Rs 5000.00 and maximum of Rs 10.00 lacs except in the case of those tenders who have specially exempted there under. DD should be in the favour of **Sr. Executive Engineer, Civil Const. & Mtc. Division PSPCL Bathinda.**
3. The Contractor shall submit the annexure A ,B & C dully filled and signed with all respect at the time of submission of his bid.
4. Conditional and incomplete tenders will not be accepted.
5. Tenderers will have to comply with all the rules and regulations under factory act, Industrial disputes act, E.P.F Act. , Labour Laws and Bonus Act & Retrenchment compensation etc.

6. The tender shall be accepted to those tenderers who have GST No, Pan No., EPF No, ESI No. & bank solvency certificate of 30 percent of tender value (Issued by bank in the current financial year ).
7. The competent authority reserves the rights to reject any or all tenders without assigning any reasons.
8. The Tenderers should provide Turnover certified Showing Average Annual Financial Turnover of the last three financial years equal to 80% of the Tender Value.
9. In case the date of opening of tenders happens to be a holiday the tender will be opened on the next working day at the same time.

9A. Completion period shall be 1 month from issue of LOI or allotment order whichever is earlier.

9. Original DD of tender fee and earnest money will be submitted by contractor in the office of Sr. Executive Engineer/CCM Division D-207, thermal colony Bathinda before date and time of opening the tender if Original DD of tender fee and earnest money will not be submitted, tender will be rejected by competent authority without any notice. Earnest money shall be submitted in separate envelope.
10. All T&P/Machinery/Labour required to carry out the work complete in all respect are to be arranged by the firm.
  - a) Generator Set-2 No.
  - b) Concrete mixers of full bag capacity- 2No.
  - c) Drilling Machine- 2 No.
  - d) Vibrator- 2 No.
  - e) Tractor Trolley- 2 No.
  - f) Portable Water Tank of capacity minimum 3000 Litres- 2No.
  - g) Adequate Shuttering.

The contractor shall provide two gangs of labourers/workers at different sites as desired by the Engineer-in-charge.

11. Cement will be supplied by the department from Shri Muktsar Sahib Store and recovery of cement will be done as per CSR-2020 Rates. (Rs.333.29) Loading, unloading and carriage of cement will be paid as per CSR-2020 rates where ever if applicable. The left out cement after work done will have to return to store by contractor at his own cost. Any other recoveries will be made from the contractors bill as per CSR-2020.
12. All statutory deductions shall be made from the bill. GST will be paid extra as per GST Act . Contractor will supply the attested photo copy of registration certificate & proof of payment against this work (Penalty for delayed payment will be charged to the contractors account). Contractors component of GST shall be paid only after furnishing of following certificates: -
  - i) Certified that transaction on which GST is claimed has been/ will be included in the returns submitted/to be submitted under GST law and the amount claimed from the PSPCL has been/ shall be deposited with GST Authorities.
  - ii) Certified that the supply on which GST has been charged have not been exempted under the GST act or rules made there under and GST charged on these supplies is not more than what is payable under the provision of relevant Act.
  - iii) Certified that we shall indemnify the PSPCL in case it is found at a later stage that wrong or incorrect payment has been received on account of GST, the same will be refunded.
  - iv) Certified that we are registered dealer under GST Act and our registration no. is \_\_\_\_\_.

- v) Further any loss due to non-availability of ITC or levy of penalty/interest payable by PSPCL on account of non-filing of return or non-compliance or any miss statement given under the provision of GST act by the contractor shall be recoverable from them.
13. Any scrap from dismantlement of old work is to be returned to store. The bricks from dismantlement are to be used for construction of new work and Melba is to be disposed of as per directions of Er-In-Charge.
  14. The negotiations if required shall be held with the lowest (L-1) tenderer only..
  15. Work Regulation 1997 with amendments from time to time will also be applicable, the copy of the same can be downloaded from PSPCL website. All DNIT conditions will also be applicable.
  16. Before any running payment is allowed against the work the contractor shall be required to sign the contract agreement. He will affix non judicial stamp papers worth Rs.50/- on the face of the agreement as required under the Indian stamp act.
  17. Any penalty imposed on factory manager/occupier by the competent court due to violation of any provision shall be recovered from contractor.
  18. Income tax will be deducted at source as per income tax act, 1961 & contractor will intimate his Pan No & Supply the attested copy of his PAN card while submitting his tender/quotation. Income tax shall be deducted from each running bill.
  19. The contractor shall deposit Labour welfare fund with welfare commissioner Punjab.( as per rules from time to time) before 15 October ( for April to September period) before 15 April ( For October to March period) under the Punjab Labour welfare fund act 2005.
  20. All safety appliances required for the workers shall be provided by the contractor and PSPCL shall not be responsible for any accident involving the workman during the course of carrying out jobs due to lack of safety appliances or the negligence of workers Contractor will nominate Safety Officer/Stewards who will visit the site on daily basis to implement safety and maintain proper record thereof.
  21. Quantity of any item can be increased/ Decreased to any extent as per site requirement. Any item of NIT can be deleted and any new item can be operated as per CSR-2020 specifications depending upon the site requirement . However, the amount of work order will remain the same.
  22. Overall lowest bidder will be consider as L-1.
  23. Security @5% will be deducted from the running/Final bills.
  24. The work should be completed in stipulated period from issue of work order/Allotment order, otherwise penalty of 0.5% per week subject to max. 5% will be charged as per 3.14 of Work Regulation 1997.
  25. If the work is delayed beyond the completion time, the application for extension of time giving detailed reasons shall be applied by the contractor and decision of competent authority shall final and binding.
  26. If the contractor refuses or neglects to execute the work, the work will be got done on his risk and cost & his earnest money will be forfeited.
