Sub : Instructions regarding ARTC Scheme for those Consumers who have not submitted test reports upto 15.11.2013.

As per CC No. 43/2013 dated 29.8.2013 last date for receiving test reports against the demand notice issued under ARTC Scheme was fixed as 15.11.2013. The instructions regarding ARTC Scheme for those consumers who have not submitted their test reports upto 15.11.2013 are as follows :-

- 1) Those who have not complied with the demand notice issued under ARTC Scheme, no further extension in demand notice shall be admissible and ARTC Scheme for this purpose shall be considered to be closed. Only those test reports received upto 15.11.2013 shall be considered for release of connections as per terms and conditions of ARTC scheme.
- 2) The prospective consumers who have not complied with demand notice issued under ARTC shall continue to have lien under general category and shall be issued demand notice under general category on their turn/seniority.

This issues with the approval of Competent Authority.


