Subject: - Revocation of Blacklisting Order dated 16.10.2025 in compliance with the order dated 22.12.2025 passed by the Hon'ble High Court of Punjab & Haryana in CWP-35885-2025.

With reference to the subject cited above, it is informed that pursuant to the decision of the Competent Authority, your firm was blacklisted vide this office memo no. 13844 dated 16.10.2025.

The Hon'ble High Court of Punjab and Haryana at Chandigarh, vide order dated 22.12.2025 passed in CWP-35885-2025 titled "M/s H.S. Electrical Contractors Vs. Punjab State Power Corporation Limited & Another", has directed the Competent Authority to withdraw the aforesaid blacklisting order and has granted liberty to the respondents to initiate proceedings afresh in accordance with law after issuance of a proper show cause notice and after affording due opportunity of hearing to the petitioner, and to pass a reasoned/speaking order, if so required.

Accordingly, in compliance with the aforesaid directions of the Hon'ble High Court and in pursuance of the liberty so granted, the blacklisting order/reference No. 13844 dated 16.10.2025 is hereby withdrawn and revoked with immediate effect in respect of M/s H.S. Electrical Contractors, Village Bhutal Kalan, District Sangrur.

It is clarified that this revocation is being effected strictly in compliance with the directions of the Hon'ble High Court and without prejudice to the rights and contentions of PSPCL. The Corporation reserves the right to proceed further in the matter, if deemed necessary, strictly in accordance with law. Any further action, including issuance of a show cause notice, shall be communicated to you separately.

This letter is issued in compliance with the directions of the Hon'ble High Court, without expressing any opinion on the merits of the case.
