Due to decrease in demand of agriculture sector, it is decided to grant Peak Load Exemption to General industrial consumers with immediate effect up to 31.5.2011. However, consumers mentioned at Sr. No. 5 (a,b,c,d) of PR Circular 6/2010 dated 31.5.10 will continue to avail Peak Load Exemption as per their requirement. Peak Load Exemption up to 100 KW is to be given by Dy CE/SE/DS concerned and Peak Load Exemption above 100 KW will be allowed by this office.

The consumers are requested to apply for Peak Load Exemption up to 100 KW to Dy CE/SE/DS concerned and above 100 KW to Dy CE/PR&C C/o CE/Metering, 220 KV Sub Station, PSPCL, Ablowal, Patiala. Consumers who want to avail Peak Load Exemption above 100 KW for first time should apply through Dy CE/SE/DS concerned, but if they have availed Peak Load Exemption above 100 KW earlier need not to root their application through Dy CE/ SE/DS concerned and apply directly to this office along copy of previous sanction letter and latest energy bill.
