TERMS AND CONDITIONS:

1 Tenders of those bidders who have purchased the tender documents/specifications shall only be opened.

2 **PQR:**

A. Tenders of only those technically suitable firm /contractor will be considered who are registered with PSPCL/PSTCL, NTPC and other such central Govt. organizations (on submission of valid registration certificate) for the jobs of:- "Erection/fabrication/replacement/repair/lying of pipelines" AND/OR "Breakdown/Preventive Mtc. & Overhauling jobs which covers steel structure and piping jobs"

B. The firm should have proof of having successfully completed/being executed the jobs of: "Erection/fabrication/replacement/repair/lying of pipelines" AND/OR "Breakdown/Preventive Mtc. & Overhauling jobs which covers steel structure and piping jobs" at Thermal/ Nuclear/ Gas power plants or other heavy industries like Petrochemical Plants, Cement manufacturing plant, Fertilizer Plant, Pharmaceutical Plant during last 7 years ending 30-06-2024 either of following:-

a) Three works as above costing (including all taxes) not less than Rs. 1,00,000/- each

OR

b) Two works as above costing (including all taxes) not less than Rs. 1.20 lacs each

OR

c) One work as above costing (including all taxes) not less than Rs. 2.0 lacs

C. **Annual Turn Over:** Average annual financial turn over during the last three year, ending March of the previous financial year, should be at least Rs. 2.0 Lacs

D. **Bank Solvency:** Latest bank solvency certificate of minimum Rs. 4.0 Lacs. Bank solvency certificate should not be more than 12 months old.

3 **Requirement for registration:**

Those tenderers who fulfill the requirement of PQR and consider themselves eligible for participation can get themselves registered with GGSSTP by submitting the attested copies of followings documents along with non-refundable registration fee of Rs. 1000/-+ GST@18% (Rs. One Thousand plus GST@18%) in cash receipt or through demand draft in favour of AO/GGSSTP, PSPCL, Ropar payable at Ropar fulfilling the following criteria:-



(i) Copies of work orders and completion certificates for experience as per PQR.

- (ii) Copies of Audited balance sheets over during the last three financial years, ending 31st March of previous financial year.
 - (iii) Bank solvency of minimum Rs. 4.0 Lacs. Bank solvency certificate should not be more than 12 months old. Average annual financial turn over during the last three year, ending March of the previous financial year, should be at least Rs. 2.0 Lacs.
 - (iv) Proof of PAN and Proof of Goods and service tax (GST) registration number.
 - (v) Proof of independent EPF account number.
 - (vi) EPF clearance certificate: EPF clearance certificate for last financial year needs to be obtained. In the event of non-availability of clearance certificate proof of deposit of EPF for last two years shall be required.
 - (vii) Proof of having ESI Code number.
 - (viii) An Affidavit in original dully attested by an Executive Magistrate/Notary to the effect that :
 - a) The firm is not defaulter in respect of deposition of EPF/ESI to the concerned EPF/ESI department for workers deployed against work orders placed by PSPCL or any other organization on it during last five years. In any case, the responsibility for deposition of EPF/ESI of workers engaged by the firm shall rest with the firm only. In case firm is found defaulter at any stage in this regard, the contract shall be cancelled without any notice.
 - b) That the firm has not been black listed by any government/public sector undertaking during the last 5 years.
4. **EMD:** - The tenderers shall be required to submit earnest money of Rs 8000/- (Rs. **EightThousandOnly**), through demand draft in favour of AO/GGSSTP, PSPCL, Ropar payable at Ropar.
Public sector undertakings fully owned by Punjab Government/center Government/ Other state Government shall be exempted from depositing earnest money, provided that the certificate of Government ownership shall be submitted in envelope for Earnest Money.
5. The firm shall have an independent EPF code number issued from the concerned RPF authority.
6. The firm shall have to obtain license under Contract Labour Regulation and Abolition Act-1970 before undertaking the work and shall abide by various provisions/rules framed there under.
7. The firm shall have valid GST no. and are registered with the concerned Department.
8. The firm shall comply with all the regulations of ESI act, amended for time to time and shall keep PSPCL free from any liability arising at any stage.
9. CE/O&M GGSSTP Rupnagar reserves the right to refuse issue of tender documents to any contractor/ firm without assigning any reason and also to reject any or all offers without assigning any reason and no claim on this account will be accepted.
10. Tenders received through telegraph, telex, fax or e-mail shall not be considered at all.
11. In case the date of opening of tenders happens to be a holiday, the tenders will be received and opened on the next working day at the same time and place.

- 12 Tenders of those firm shall be rejected who are black-listed or with whom business dealing are suspended by PSPCL.
- 13 In case of any dispute regarding issue of tender documents or any other dispute, C.E., GGSSTP, Ropar, shall be the final authority and no claim on this account shall be accepted.
- 14 Quotation/Tender should be enclosed in double covers both addressed to Dy CE/Head Quarter, GGSSTP, PO: Ghanauli, Distt. Ropar (PB) PIN-140113. Both inner & outer covers shall be sealed and super scribed with Tender Enquiry No. as given on the enquiry/Tender Notice together with the date on which the tender opening is due and also the name of work.

Part-II: Price bid.
- 16 Splitting of work: Chief Engineer/GGSSTP reserves the right to split up the work in the scope of this contract among more than one contractor.
