5) Negotiations shall not be held excepting with the lowest tenderer.

TERMS AND CONDITIONS:

1. The contractor shall have to purchase tender documents from the office of SE/Hq, GGSSTP Rupnagar on payment of Rs. 1180 /- (inclusive of GST @ 18%) towards the cost of each tender documents by BA-16 cash receipt issued by AO/O&M, GGSSTP, Ropar or through demand draft drawn in favour of AO/O&M, GGSSTP, Ropar payable at Ropar.

2. Pre Qualification Requirements (PQRs) for tenderers:

A The work is proposed to be got done from those firm who has experience of carrying out similar / same type of works.

Documentary proof of experience must be submitted along with commercial offer for ascertain technical suitability of the firm in respect of above PQR. No additional registration is required.

- B Average annual financial turnover during the last 3 years, ending 31st March of the previous financial year, should be at least Rs. 1,93,070/-
- C Balance Sheet: Copies of Audited balance sheets for past three financial years shall be submitted.
- D Copy of valid/ active PAN No
- E Proof of having GST registration numbers
- 3. Bid should be submitted in two parts:-

Part-I: Tender document fee & Earnest Money Deposit.

Part-II: Techno Commercial bid & Price bid.

Part-II of those firms who didn't submit requisite amount of EMD (Part II above) shall not be opened.

4. EARNEST MONEY:

The tenderers shall be required to submit earnest money at the following rates in the form of PSPCL cash receipt or Bank Draft payable at Rupnagar in favour of AO/GGSSTP, Rupnagar before the last date & time of receipt of tender.

- a) Tender valuing up to Rs.50, 000/-= NIL
- b) Tender valuing above Rs.50, 000/- = @2% of tender value rounded off to multiple of Rs.10/= on higher side subject to and Maximum of Rs.10, 00,000/- and minimum of Rs.5, 000/-.

All the tenders must be accompanied by requisite earnest money. Tenders received without earnest money shall be rejected.

Public Sector undertakings fully owned by the Punjab Government/ Central Government / Other State Govt. shall be exempted from depositing Earnest Money, provided that a certificate of Government ownership shall be submitted in the envelope for Earnest Money.

5. Original Demand drafts towards Earnest money deposit should be enclosed in separate cover and further put in single cover. These are to be addressed to:-

Both inner and outer cover should be super subscribed with tender specifications/ enquiry no. as given in the tender notice together with the date on which the tender opening is due and name of the work.

- 3. The Performa for price schedule enclosed with tender shall be filled by the tenderer which is attached as Annexure-A of tender specifications.
- 5. Tenders received telegraphically, through E-mail, telex or fax shall not be accepted.
- 6. The tenderer must read all Terms & Conditions of the tender specifications and must abide by all the Terms & Conditions. No conditional tenders are accepted.
- 7. The tender must be valid for at least 120 days from the date of opening of tenders.
- 8. If the due date happens to be holiday, tenders shall be opened on the next working day at the same time.
- 9. Tenders of firm/contractors who are black listed or with whom business dealings are suspended by PSPCL will be rejected.
- 10. GGSSTP reserves the right to allot whole or part of the work to any tenders without assigning any reason.
- 11 The firm will submit contract agreement on Non-judicial stamp papers of Rs. 50/-before start of work
- Firms which are registered with MSME are required to provide documentary evidence (Latest copy of memorandum of Micro Small & Medium Enterprises filed under section-8 of MSMED Act, 2006 duly acknowledged by competent authority.) of being Micro, Small & Medium Enterprise. If the bidder does not submit the proof at the time of submission of its bid, it shall be considered as a large enterprise.
- Constitution, Experience and Financial Standing:
 - The tenderers shall invariably supply the following information with the Tenders:
 - a) Constitution and composition of the firms: Documentary evidence (Latest copy of memorandum of Micro Small & Medium Enterprises filed under section-8 of MSMED Act, 2006 duly acknowledged by competent authority) of being a Micro, Small & Medium Enterprise. If the bidder does not submit the proof at the time of submission of its bid, it shall be considered as a Large Enterprise.
 - b) A certificate for the last financial year, duly signed by any Director/Partner/Proprietor and Chartered Accountant that investment in Plant & Machinery of the enterprise does not exceed Rs. 25 Lac in case of micro and Rs. 5.00 Cr. In case of small enterprise as prescribed in section 7 (1) a(i) & (ii) of the MSMED Act, 2006.
