TERMS AND CONDITIONS:-

1. The details of job/work to be carried as per Technical Scope of Work (Section-III).
2. Only those firms shall be considered eligible who have done rewinding of complete stator of HT motor/ Turbo-generator/Hydro-generator having rating of 6.6KV or above during last five years. The firm shall upload copies of W.O.'s (along with completion certificates) or any other relevant documents in favor of above.

The firm shall also upload required documents/certificates:

- a) **Turn Over:** The bidder should be financially sound and must have a average annual turnover of **10.00 Lac** during last 3 years, ending 31 March 2020.
- b) Only those firms shall be considered eligible who have VPI processed insulation facility for motor of minimum Height of 1700mm, length of 3500mm & width 2400mm with connection box and upload supporting documents.
- c) Proof of having GST registration number.
- d) Copy of PAN Card as proof of having PAN No.
- e) A self attested undertaking that the firm has not been blacklisted any Govt. / public sector undertaking during the last five year.
3. The rates should be quoted as per reference Performa (Section-V). Bidders have to submit Price bid in Electronic format only on website <https://eproc.punjab.gov.in> till the last due date & time for submission. Conditional or incomplete tenders shall not be accepted.

NOTE:-Tenders received telegraphically, through Telex or Fax or E-mail shall not be accepted.

4. Quoted rates must be valid for a period of at least 120 days from the last date of opening of price bid.
5. All tenderer (s) shall be required to transfer earnest money as per rules & regulations of the PSPCL.
 - i) The tenderer (s) shall be required to deposit fixed earnest money Rupees Twenty Thousand (Rs. 20,000/-) electronically on PSPCL website **<https://eproc.punjab.gov.in>**.
 - ii) Public Sector undertakings fully owned by the Punjab Government/ Central Government/Other State Govt. shall be exempted from depositing Earnest Money, provided that a certificate of Government Ownership shall be uploaded on PSPCL website **<https://eproc.punjab.gov.in>**.
 - iii) Earnest Money shall be forfeited in case of withdrawal/modification of an offer within the validity period, as required in the NIT/Tender Specification after opening of tender.

- iv) In case of successful tenders, Earnest Money shall be converted as Security Deposit.
 - v) In case of tenders not accepted/un-successful tenderer (s), the Earnest Money shall be refunded within 30 days of the award of order/contract to the successful tenderer (s) or after the expiry of additional period whichever is later.
6. The price bid shall be opened after satisfying that the tenderer is qualifying the conditions prescribed in the tender specifications. The date of opening of price bid shall be intimated later on to the qualifying bidders. In case the above scheduled date happens to be a holiday, the bids shall be opened on the next working day. All Saturdays & Sundays are regular holidays.
 7. Tender shall be evaluated on the basis of overall lowest rates.
 8. The rates quoted should be firm and **exclusive** of GST.
 9. PSPCL/GHTP, Lehra Mohabbat reserves the right to reject any or all the offers without assigning any reason and no claim on this account will be accepted.
