- 2) (I) The interested contractors / Firms must submit their request for issue of tender specifications by **29.01.2026** till **12.30 PM** along with the cost of tender specification by cash or demand draft in favor of **Additional Superintending Engineer, DS City West Division (spl), PSPCL Ludhiana** on any scheduled bank payable at Ludhiana.
- 3) (II) This payment is not refundable in case of firms/contractors who qualified for the issue of tender documents. In case of firms/contractors, who don't prequalify for

issue of tender documents, half the amount deposited against cost of tender specifications will be refunded.

- 4) The tender specification shall be issued to eligible bidders by **29.01.2026 till 10:00 AM**. The detail of receipt & opening of tenders in this office are given below:-
