

Submission of Tender: The tenders should be submitted as per NIT/Tender Specifications complete in all respects in two parts i.e. Part-I: Technical bid comprising of EMD (If applicable) and Documents as per Eligibility criteria and Part-II: Price bid. These bids shall be submitted in two separate sealed envelopes duly subscribed on the envelope as PART-I and PART II. If bids are not submitted in this manner or Documents/EMD in Part 1 is incomplete as per Eligibility criteria. Price bid will not be opened and the tender bid will be rejected.
- 3. Earnest Money should be deposited along with tenders as per tender notice. Tender without Tender Cost and EMD (if applicable) shall not be accepted. In case of tender not accepted, the Earnest Money shall be refundable within 30 days of the award of Order/Contract to the successful tenderer.
