TERMS AND CONDITIONS:

- 1. Tenders of those bidders who have purchased the specifications shall only be opened and considered.
- 2. Tender shall be submitted in duplicate. The tender shall be in two separate envelopes, one envelope containing the main tender and the other containing the earnest money. While opening the tender, the envelope containing Earnest Money shall be opened first. In case the deposit of Earnest money is not as per clause 8, then the main tender shall not be opened and the tender shall be treated as invalid.
- 3. Quotation/Tender should be enclosed in double cover both addressed to Dy. CE/Montg., GGSSTP, Ropar, Punjab Both inner & outer covers shall be sealed and superscribed with Tender Enquiry No. as given on the enquiry/Tender Notice together with the date on which the tender opening is due and the name of work.
- 4. Tenders received telegraphically, through e-mail, telex or fax shall not be accepted.
- 5. The tender must be complete in all respects. Conditional, incomplete or not properly sealed tenders and Tenders received after the last date & time of opening of tender shall not be accepted, In case the date of opening of tenders happens to be a holiday, the tenders will be received and opened on the next working day at the same time and place.
- The firm shall have PAN & GST number issued from the concerned authority.
- 7. The contract can be terminated after giving 15 days notice by Engineer-In-Charge of PSPCL without any additional liability to PSPCL without assigning any reasons, whatsoever
- 8. The tenderers shall be required to submit EARNEST MONEY @ 2% of the tender value rounded of to a multiple of Rs. 10 on the higher side subject to minimum Rs. 5,000/- & maximum of Rs.10 Lacs in the form of PSPCL Cash Receipt/Bank Draft

in favour of AO/O&M, GGSSTP, PSPCL, Rupnagar, payable at Rupnagar along with the Tender

Public Sector undertakings fully owned by the Punjab Government/ Central Government / Other State Govt shall be exempted from depositing Earnest Money, provided that a certificate of Government ownership shall be submitted in the envelope for Earnest Money.

- 9. I)Tenders of the firms who are registered with GGSSTP/GHTP/GNDTP for this job & have carried out the jobs of bullet shot cleaning with BHELINTPC/ SEB's/Power Utilities are eligible to participate. The firm should have annual average turnover during the last 3 years, ending FY 2019-20, more than Rs. 1.45lacs and have experience of execution of jobs of bullet shot cleaning during last seven years ending 31.08.2020 as below:
- a) Single, completed/being executed work order costing (including all taxes) not less than 1.45 Lacs

OR

 Two, completed/being executed, work orders each costing (including all taxes) not less than 0.87 Lacs.

OR

c) Three, completed/being executed, work orders each costing (including all taxes) not less than 0.72 Lacs.

Note:

- Completion certificate is must against each completed work order, placed on firm other than PSPCL.
- In case work order(s) is/are under execution as on the date of 31.08.2020 the
 value of work completed till 31.08.2020, will be considered provided the value of
 executed work is certified by the work order issuing authority.

Firms should be registered with GGSSTP/ GHTP /GNDTP/ NTPC or other such central/state govt. organizations for the above said work. However contractors/firms shall have to fulfill PQRs, all clauses of the NIT/Tender specifications of the tender and shall submit self-attested hard copies of proof of valid registration and documents as per PQRs before the last date and time of registration. Their bid will only be considered if the documents submitted are found in order.

- ii) Annual Turn Over: Average annual financial turnover during the last three years, ending 31st March of the previous financial year, should be at least Rs. 1.45 Lacs.
- iii) Bank Solvency: Latest bank solvency certificate of minimum amount of 2.90 Lacs. Bank solvency certificate should not be more than one year old from the date of opening of tenders.

- 10. Those tenderers who consider themselves eligible for the work can get themselves registered with GGSSTP by submitting requisite documents of financial soundness and technical suitability along with registration fee of Rs 1000/- plus GST.For registration apply along with following:

(a) Bank DD for Rs.1000/- plus GST in favour of AO/O&M, GGSSTP, PSPCL Rupnagar payable at Rupnagar as registration fee.

(b) Attested photocopies of EPF no., ESI no., GST no., PAN no.

(c) Bank solvency of minimumRs. 2.9lacs

(d) Balance sheet of company for the last three years.

(e) Attested photocopies of minimum work orders executed for 'Cleaning of condenser tubes by using bullet shot technique as detailed in 9 above.

(f) An Affidavit in original dully attested by an Executive Magistrate/Notary to the effect that:

i) The firm is not defaulter in respect of deposition of EPF to the concerned EPF/ESI department for workers deployed against work orders placed by PSPCL or any other organization on it in the last five years. In case firm is found defaulter at any stage, the contract shall be cancelled without any notice.

ii) That the firm has not been black listed by any government/public sector undertaking during the last 5 years.

The applications for fresh/renewal of registration must reach this office, at least Ten days before the date of opening of tender. Applications received late shall not be considered.

- 11. The tender must be valid for at least 120 days from the date of opening of tenders.
- 12. EIC/CE, GGSSTP, Ropar reserves the right to reject any or all offers of the firms without assigning any reason and no claim on this account will be accepted.
- 13. The contractor should have independent GST No. allotted and will submit a copy of the same.
- 14. The firm/contractor must have EPF Code and shall comply with all the rules and regulations of the Act, applicable from time to time and shall keep GGSSTP/PSPCL free from any liability whatsoever against this Act.
- 15. The firm shall follow the Rules and Regulations of Employees State Insurance Act.
- 16. The tender must be complete in all respects. Conditional, incomplete or not properly sealed tenders and Tenders received after the last date & time of opening of tender shall not be accepted. In case the date of opening of tenders happens to be a holiday, the tenders will be received and opened on the next working day at the same time and place.
