- 2. Quotation should reach in the office of the undersigned before 2:00 PM on or before 17/11/2025. If this day happens to be a holiday, the quotation can be submitted on the following working day and the same shall be opened in that day.
- 3. The quotation received before the above-mentioned times shall be opened at 3:00 PM on 17/11/2025 the same day in the presence of committee of officers/officials of the department and representatives of the contractors who want to be present.
- 4. Quotations not accompanying the required earnest money will not be entertained.
- 5. Quantity of the work can be increased or decreased.
- 6. Conditional tenders will not be entertained.
- 7. Work shall be carried out as per PWD specifications to meet with the requirements of the work at site to the entire satisfaction of the engineer-in-charge.
- 8. Rates quoted shall be inclusive of all taxes except GST, which shall be paid extra as applicable.
- 9. Payments shall be made on the work done measured by the department and accepted by the contractor.
- 10. PSPCL work Regulation 1997 with latest updates shall be applicable.
- 11. The completion period of the work is **60 days** from the date of allotment or LOI, whichever is earlier.
- 12. Security Deposits: The earnest money deposited at the time of tender shall be converted into Security Deposit. The Security Deposit will be deducted from the running bills at the rate of 5% of the gross value of the work done from time to time after taking
