1) The approval be and is hereby accorded to incorporate the following in Corporate Transport Policy of PSPCL.

2) The approval be and is hereby accorded to incorporate/modification in Corporate Transport Policy of PSPCL in para- 2(C)(iv) as under:-

The Work Order for out-sourcing of vehicles, for the vehicles not more than 5 years old, shall be initially for a period of one year and the same shall be extendable on year to year basis for a further period of three years, on the satisfactory performance of the vehicle/service provider subject to condition that the vehicle can continue in the department upto the 7 years of its life. Hence the maximum period for which a vehicle can be hired is 4 years. After a period of 4 years, a new tender needs to be floated.

All other terms condition will remain the same.
