

**GLOBAL INVITATION FOR EXPRESSION OF INTEREST (EoI) FOR SELECTION OF DEVELOPER FOR 55.5 MW
SHAHPUR KANDI EXTENSION HYDRO ELCTRIC POWER STATION TO BE SET UP ON RIVER RAVI IN
DISTRICT GURDASPUR OF PUNJAB, INDIA**

Opportunity:

Punjab State Electricity Board (PSEB) through its Hydel Department has initiated process of development of 55.5 MW Shahpur Kandi Extension Hydro Electric Project by the reputed private sector Developer on Build, Own, Operate and Transfer (BOOT) basis.

Project:

Project includes Establishment, Operation and Maintenance of 55.5 MW Shahpur Kandi Extension Hydro Electric Project for 35 years from Date of Commercial Operation (CoD) of first unit. The Project shall be transferred back to PSEB after 35 years.

Project Site:

The Shahpurkandi extension hydro project consisting of 3 No. Power Houses ($2 \times 10.5 + 2 \times 10.5 + 2 \times 6.75 = 55.5 \text{ MW}$) is to be constructed on the existing UBDC main canal which takes off from Modhopur Head works, after re-modeling of UBDC canal from RD 0 to RD 65000. The site for the proposed Shahpur Kandi Extension Project is located on UBDC main channel in District Gurdaspur of Punjab, India. The site is about 10 Km away from Pathankot and 120 Km away from Amritsar. The site can be approached from Pathankot Jammu National Highway No.-I A or from nearest railway stations at Madhopur and Pathankot. The draft DPR is available in the office of Director RSPP which can be consulted.

Applicant:

The applicant may be a single entity or a multiple entity consortium coming together to implement the project. Consortium as a whole must have necessary technical and financial expertise to execute large project of this size. The members shall be jointly responsible. The requirements are as under:

Requirements:

- The applicant must have proven experience of developing projects in the field of Hydro Power Generation or any other infrastructure project of similar size or higher. The applicant shall also submit details of all such projects executed by them.
- The applicant shall have a track record of profitability and shall have financial capability to execute such project. The Applicant shall also submit their last three years audited accounts.

The Applicant shall submit all the necessary details in not more than 15 pages.
