TERMS AND CONDITIONS:

1. A set of tender documents (non-transferrable) containing scope of work and terms & conditions can be obtained from the office of SE/Hq, GGSSTP P.O. Ghanauli Ropar Punjab 140113 by remitting its cost (non-refundable) in cash or through demand draft in favour of AO/GGSSTP, PSPCL Ropar payable at Ropar. Tenders of those bidders who have purchased the specifications shall only be opened and considered.
2. **P.Q.R:-** The firms who meet the following conditions are eligible to participate in e-tender enquiry

1. Tenders of only those firms/contractors will be considered who are registered with PSPCL /PSTCL/NTPC and other such central Govt. organizations for the jobs of Painting works on Civil/Steel structure/vessels/tanks/Pipelines etc. Further the firm should have experience of Painting works on Civil/Steel structure/vessels/ tanks /Pipelines etc at PSPCL/ PSTCL/ PWD/Railway/MES/any industry/ any thermal/ Nuclear/ Gas/Hydro plant during last seven year ending 31.03.2025 as below:-

- a) Three same works costing not less than Rs. 1.13 Lacs/- each OR
- b) Two same works costing not less than Rs. 1.36 Lacs/-each OR
- c) One similar work costing not less than Rs 2.26 Lacs/-each.

Note:

- (i) Work order value shall be considered on one year basis.
- (ii) In case work order period falls beyond the seven year period then proportional amount of work order value will be considered as executed work, against the work order.
- (iii) Completion certificate is must against each completed work order, placed on firm other than PSPCL
- (iv) In case work order(s) is/are under execution as on the date of 31/07/2024, the value of work completed till 31/07/2024, will be considered provided the value of executed

work is certified by the work order issuing authority.

2. **Average Turn Over:-** Average annual financial turn over during the last three years, ending March of the previous financial year, should be at least Rs. 2.26 Lacs/-.
3. **Bank Solvency:-** Latest bank solvency certificate of minimum amount of Rs. 4.52 Lacs. Bank solvency certificate should not be more than twelve months old.

The firms/ contractors who consider themselves eligible for participation can get themselves registered with GGSSTP by submitting the attested copies of followings documents.

The firm will deposit registration fee of Rs. 1,000/- (Rs. One thousand only) + GST@18% through bank demand draft in favour of AO/GGSSTP, PSPCL and payable at Ropar

- i) Copies of work orders and completion certificates for experience as per PQR.
- ii) Copies of Audited balance sheets (profit & loss sheet) over during the last three financial years, ending 31st March of previous financial year.
- iii) Annual turnover: - Average annual turnover during last 3 years, ending 31 March 2025, should be at least 2.26 Lacs
- iv) Bank Solvency:- Latest bank solvency certificate of minimum amount of Rs. 4.52 lacs and should not be more than twelve months old from the date of opening of tender.
- v) Proof of PAN and Proof of GST number.
- vi) Proof of independent EPF account number.
- vii) EPF clearance certificate: EPF clearance certificate for last financial year needs to be obtained. In the event of non-availability of clearance certificate proof of deposit of EPF for last two years shall be required.
- viii) Proof of having ESI Code number.
- ix) An Affidavit in original dully attested by an Executive Magistrate/Notary to the effect that :-
 - a) The firm is not defaulter in respect of deposition of EPF to the concerned EPF/ESI department for workers deployed against work orders placed by PSPCL or any other organization on it in the last five years. In case firm is found defaulter at any stage, the contract shall be cancelled without any notice.
 - b) That the firm has not been black listed by any government/public sector undertaking during the last 5 years.
- x) The registration of the firm will be done on merit on the basis of credentials of the firm and decision of Chief Engineer/ GGSSTP shall be final in this regard.
4. The request for registration by new firms must reach the office of registering authority at least five working days **prior to last date of downloading of tender documents**. Tender will be considered if the registration of the firm is done on or before the last date of bid submission. The firms, already registered with PSPCL for this work, will have to meet the criteria of PQR to be eligible for this tender.
5. The tender must be valid for at least 120 days from the date of opening of tenders.
6. Period of contract: - The work shall be completed within 120 days from the issue of W.O. However it can be varied depending upon the weather conditions etc. The decision of Engineer-in-Charge shall be final. The firm cannot claim extension as a matter of right.

7. The firm shall have to obtain license under Contract Labour Regulation and Abolition Act-1970, if applicable, before undertaking the work and shall abide by various provisions/rules framed hereunder.
8. Tenders received after the last date and time of submission of tender shall not be accepted.
9. The firm will submit list of T&P and persons to be deployed.
10. CE GGSSTP, Ropar reserves the right to refuse to issue of tender documents to any contractor/firm without assigning any reason and also to reject any or all offers without assigning any reason and no claim on this account will be accepted.
11. Tenders received through telegraph, telex, fax conditional tender or manually shall not be considered at all.
12. In case the date of opening of tenders happens to be a holiday, the tenders will be received and opened on the next working day at the same time and place.
13. The firm shall have an independent EPF, ESI code number, PAN, GST number, issued from the concerned authority.
14. The contract can be terminated after giving 15 days notice by Engineer-In-Charge of PSPCL without any additional liability to PSPCL without assigning any reasons, whatsoever
15. The tenderers shall be required to submit EARNEST MONEY @ 2% of the tender value rounded off to a multiple of Rs. 10 on the higher side subject to minimum Rs. 5,000/- & maximum of Rs.10 Lacs in the form of PSPCL Cash Receipt/Bank Draft in favour of AO/O&M, GGSSTP, PSPCL, Rupnagar, payable at Rupnagar along with the Tender.
Public Sector undertakings fully owned by the Punjab Government/ Central Government / Other State Govt. shall be exempted from depositing Earnest Money, provided that a certificate of Government ownership shall be submitted in the envelope for Earnest Money.
16. Tenders received without Earnest Money shall not be opened.
17. The firm shall follow the Rules and Regulations of Employees State Insurance Act. 1948.
18. Tenders of those firms shall be rejected who are blacklisted or with whom business dealings are suspended by PSPCL.
