- 1. Please go to https://exams.nta.ac.in/PSPCL/
- 2. Go the Link "Click Here to Answer Key Challenge"
- 3. Login with your Registration Number and Date of Birth and enter Security Pin as displayed and press the Login button.
- 4. Click on "View" (blue colored link) for viewing your marked responses.
- 5. To View & Challenge the Answer keys, click on the link "Answer Key Challenge" Button.
- 6. The First column is 'SR. No.', the second column is 'Question IDs', the third column is the 'Correct Option(s)' and fourth column is to select one of the Option/Answer for Challenge.
- 7. If you wish to challenge any Question then you may use any one or more of the options given under in the column 'Option/Answer for Challenge' by clicking the check box(s).
- 8. After clicking your desired option, scroll down, upload the supporting documents. For which you can select 'Choose File' and upload (all documents to be put in a single pdf file).
- 9. To save your challenge enter the Captcha value. Press the "Proceed for Review Claims" button. A message on screen showing "Data Saved Successfully" shall pop up.
- 10. In case you wish to modify the claims, click on 'Modify your Claims' else press the 'Final Submit' button to submit your challenge(s).
- 11. After completing the process, you can see on your Challenges displayed on the screen by pressing the "View' button.
