**Subject:** Manufacturing, stacking, curing and testing of 45600 no. 9m long PCC poles & 2,560 no. 11m long PCC poles as per PSPCL specifications at Pilot Workshop, Sarna (Pathankot) – T.E. No. 01/2024-25/PWMDI - **Forfeiture of EMD and Blacklisting.**

The subject cited work against Tender Enquiry No. 01/2024-25/PWMDI, opened on 05.08.2024, was allotted to your firm M/s Rajeshwar Singh, Pathankot vide allotment order dated 12.09.2024 within the bid validity period at the rates quoted by you in the reverse auction. However, despite issuance of the allotment order, your firm neither commenced the work at the site nor executed the contract agreement, which is a clear violation of the tender terms and conditions.

Thereafter, your firm served a Legal Notice dated 19.09.2024 demanding refund of the earnest money. The said notice was duly replied to you vide this office letter dated 01.10.2024. In this reply, it was clearly conveyed to you that action is being initiated against your firm strictly as per the relevant clauses of DNIT and the allotment order, which specifically provide for forfeiture of EMD and suspension of business dealings / debarring / blacklisting in case of default.

Further, a personal hearing was granted to you by the Committee of Whole Time Directors (WTDs) of PSPCL on 21.08.2025 at PSPCL Head Office, Patiala, in which you personally appeared. After due consideration of the record and submissions, the Committee observed that your firm failed to commence the allotted work and did not execute the agreement, which led to cancellation of the tender and re-allotment of the work at higher rates, thereby causing financial loss to PSPCL. After carefully examining the record and considering the oral submissions made by your firm, the Committee found no cogent reasons advanced by your firm for the default.

The Committee of Whole Time Directors, PSPCL, therefore decided as under:

1. The Earnest Money Deposit (EMD) amounting to Rs.7,64,000/- deposited by your firm i.e. M/s Rajeshwar Singh, Pathankot against Tender Enquiry No. 01/2024-25/PWMDI is hereby forfeited.
2. Your firm, M/s Rajeshwar Singh, Pathankot, is hereby blacklisted for a period of one year with effect from the date of issue of this letter.
