as per Regulation 10(4) of Supply Code 2024.

In compliance with Regulation 10(4) of the Supply Code, 2024 and PSPCL's Instructions issued vide Memo No. 304-310 dated 17.03.2023 mainly for unauthorized colonies, following instructions regarding submission of NOC for release of electricity Connections may be noted for compliance:-

- 3.3.5 Release of DS/NRS/Industrial/Bulk Supply connections (including extensions) in Chandigarh periphery area.
- No connection / extension in load to the above categories of consumers within the a) periphery area of capital city Chandigarh (list of villages given in Annexure-40) is to be released without obtaining NOC from PUDA / GMADA or any other authority notified by the State Govt. However in the following cases NOC need not to be obtained:-
 - Industrial Units located within the Industrial focal points set up by the Deptt. i. of Industries/PSIDC.
 - Industrial Units located in villages which fall entirely within Free ii. Entrepreneur Zone (list of villages given below).
 - Reconnection orders where there is no increase in load. iii.
 - iv. Agricultural power supply connections.
 - Connections for residential purposes within the Lal lakir or phirni of a village ٧. subject to the report of Patwari concerned.

Note: Regular domestic supply connection on temporary basis under normal DS tariff may be released to an applicant falling in the Chandigarh periphery area subject to furnishing of undertaking that connection will be disconnected, if the premises is declared illegal by the State Government. Such applicants shall be required to pay the dismantlement charges on actual basis in case of termination of agreement.

For electric connections in the Municipal areas of Kharar, Dera Bassi, Banur and b) NAC of Zirakpur, NOC will be issued by the Executive Officer of the concerned Municipal Council / NAC and not PUDA/GMADA.
