Sub: Recovery of arrear on account of voltage surcharge @ 10%/17.5% from the consumers having contract demand above 2500KVA upto 4000KVA and exceeding 4000 KVA respectively.

Commercial Circular 66/2007 dated 28.11.2007 was issued for recovery of arrears on account of voltage surcharge @ 10% / 17.5% w.e.f 1.4.2004. The last para of the commercial circular reads as under:-

"In view of orders dated 13.10.2006 of PSERC, PSEB has to implement the orders of PSERC and to levy voltage surcharge w.e.f. 1.4.2004. In this context, voltage surcharge has already been levied w.e.f. 11.4.2007 and now it has been decided to recover the arrears of voltage surcharge from 1.4.2004 to 10.4.2007.

Now in view of the judgement of Hon'ble Punjab and Haryana High Court on dt.09-09-2011 in the various LPAs in the matter, it has been decided to recover the arrears of voltage surcharge from 1.10.2004 to 10.4.2007 instead of 1.4.2004 to 10.4.2007.

The commercial circular CC-66/2007 is deemed to be amended to the above extent only.


