Subject: Black listing and debarring of any type of business dealing with PSPCL for five years.

Your firm has entered into an Contract agreement No. 76/HPs/ED-I/S-290 dated 22.01.2010 for the repair damaged runner of 50 MW machine. During the agreement following defaults / violations were detected as under:

- 1 Your firm failed to provide at least 1 healthy repaired runner available to meet with emergency along with poor workmanship of repair.
- 2 Your firm failed to supply 2 No. New runners.
- 3 Contract was signed by concealing facts & figures about the firm.
- 4 Contract was signed on behalf of non registered / non existing Company and contract became void abinitio.

Due to above mentioned defaults / violations, Contract agreement was terminated vide memo No. 02265/HPs/ED-I/S-290 dated 20.9.2011. Therefore, PSPCL has decided to blacklist & debarred your firm for any type of business dealing for a period of 5 years.
