In continuation to this office Order No. 156/Fin/PRC-1988 dated 10-5-89 F/C No. 30/89) , In order to ensure proper utilization of accommodation available at the projects and to stop undue benefit of additional 5 % rent to employees staying in their own houses or staying in hired houses in their own interest, The Punjab State Electricity Board is pleased to order to stop the additional payment of 5% rent in lieu of entitlement of rent free accommodation to the Board employees residing in private accommodation through out the State with immediate effect. The genuine cases for payment of 5 % of additional rent, if any, shall be considered subsequently and specific approval conveyed by the competent authority. It is further decided that in addition to above wherever Board's accommodation of the appropriate category is available, the same shall be allotted to the concerned officials and those who do not occupy the accommodation and preferred to stay outside in a rented accommodation, shall also not be given the House Rent Allowance. It is, however, made clear that Board officials who are staying in their own houses/ Houses in the name of a member of the family shall continue to get the House Rent Allowance for staying outside PSEB Colonies.


