Subject:- Economy in expenditure – Travel by Air – Relaxation thereof.

The Board while continuing the economy measures vide memo No.120857/897/Fin-49/76-77 dated 1.4.2002 issued vide Finance Circular No. 3/2002 dated 1.4.2002 had modified the provision for entitlement to Air Travel as under:-

"(2) The entitlement to travel by Air.

" In addition to all Grade-I officers, who can travel by air for distance more than 1000 KMs at their discretion, other officers drawing basic pay less than Rs. 17,600/- but not below Rs.14,500/- may be permitted by their HODs to travel by air in emergent cases if the distance of travel is more than 1000 KMs".

2. The matter has been considered and it has been decided that concurrence of Finance in relaxation of instructions already issued vide FC No. 3/2002 dated 1.4.2002 in respect of entitlement to travel by air in individual cases, may be obtained by the HODs in respect of their own cases and the officers working under them who are drawing basic pay less than Rs. 17,600/- but not below Rs. 14,500/- where the journey performed by Air by them, is short by a margin of 10 KMs to 20 KMs of the prescribed limit of 1000 KMs.

by justifying the journey with facts that the same has been performed in emergent circumstances by them or the officers working under them as mentioned above, in the interest of the Board.

Continuation this office memo No. 88217/88866/PRC/A-136/L dated 15.9.2003 issued vide FC No. 19/2003 dated 15.9.2003; it has been notified with prospective effect that there shall be no different induction levels/categorization for the grant of Time Bound Promotional Scales and the deviations already made in changing induction levels will be treated as redundant for future application.

2. The CAO/PSEB, has sought for clarification – as to whether the instructions issued vide ibid notification are applicable in respect of employees who have been promoted after passing the Departmental Accounts Examination to the higher posts i.e. from LDC to UDC, Revenue Accountants/Divisional Accountants and SAS Accountants respectively or who entered into Board's service on or after 15.9.2003 i.e. the date of issue of ibid circular.

3. The matter has been considered, it has been decided that in the case of employees whose induction level posts for the grant of Time Bound Promotional Scales have been changed after passing the Departmental Accounts Examination from lower to higher posts before the issue of ibid instructions vide FC No. 19/2003 dated 15.9.2003 and they have not availed the benefit of Time Bound Promotional Scales of any lower post.

Sir,

I am directed to refer to this department circular Letter No. 3/2/97-FP1/7100 dated 19<sup>th</sup> October, 2004 on the subject cited above and to say that the Governor of Punjab is pleased to decide that the Dearness Allowance payable to Punjab Government employees shall be enhanced from existing rate of 14% to 17% of pay w.e.f. 1.1.2005. The amount due from the 1<sup>st</sup> January, 2005 to 31.3.2005 under these orders shall be credited to the General Provident Fund Accounts of the employees and it shall be treated as additional subscription and interest thereon shall accrue from the first day of the month next to the month in which the amount is drawn and credited to the accounts of the employees. The amount due from 1<sup>st</sup> April, 2005, under these orders shall be paid in cash.

2. The provisions contained in Paras 3,4,5,6 and 9 of this Department circular letter No. 3/2/97-FP1/3346, dated 24<sup>th</sup> April, 1996 and Para 2 of circular letter No. 3/2/97-FP1/3504, dated 16<sup>th</sup> April, 2002 shall continue to be applicable regarding payment of Dearness Allowance under these orders.

Subject: Revival of old rates of TA/DA and L.T.C. to all Board employees.

The Board had revised the rates of TA/DA and grading of the employees in various pay ranges in the new pay scales, vide this office O/O No. 359/Fin-II dated 15.1.99 (FC No. 5/99) w.e.f. 1.1.99 after adopting the State Govt. Notification dated 5.8.1998.

2. Subsequently, while adopting economy measures, the admissibility of TA/DA, Grading of employees, entitlement to travel b y Rail and Air, rates of Road Mileage, Hotel Accommodation/Bungalows for tour outside Punjab was curtailed including freezing of the facility of L.T.C. vide FC Nos. 29/2001 and 3/2002 respectively and the facility of L.T.C. was limited to the retiring employees only vide FC No. 4/2003 dated 13.3.2003 and was extended from time to time.
3. The matter regarding admissibility of TA/DA etc. and grant of L.T.C to all employees has been reviewed and it has been decided to restore with immediate effect the admissibility of TA/DA etc. as per FC No. 5/99 dated 15.1.99 and provide the facility of L.T.C. to all employees instead of retiring employees only.




