I am directed to refer to this department letter No. 1/7/98-1FPPC/6884  
dated the 25<sup>th</sup> August, 2005 on the subject cited above and state that each  
pensioner was required to apply for revision of pension/family pension/in terms  
of these orders within a period of 180 days from the date of issue of these  
orders. It has come to the notice of the Government that many pensioners who  
are bed ridden due to ill health/old age, living in remote areas are still unaware  
of the benefits laid down in the above-mentioned letter and could not submit  
their option within the stipulated period which expired on 24-02-2006. It has,  
therefore, been decided to extend the period for submission of application for  
revision of pension/family pension for another period of six months i.e. up to  
24-08-2006. It may please be brought to the notice of all concerned.

In supersession of office order No. 414/Fin-II/19(98) Dated 25.10.2001, the Punjab State Electricity Board is pleased to allow equivalent to six increments as Hardship Allowance to the officers and regular staff both headquartered at Shanan, Joginder Nagar and Brot, at par with BBMB, on the following terms & conditions:-

- I. The 'Shanan Allowance' and 'Brot Allowance' will not be treated as pay.
  - II. The 'Shanan Allowance' and 'Brot Allowance' will be effective only so long as an employee remains posted at Shanan, Joginder Nagar and Brot. On transfer from these stations, the 'Shanan Allowance' and 'Brot Allowance' will cease to be admissible.
  - III. For the purpose of this order, the word 'increment' would mean the annual rate of increment being drawn by an employee on 20.6.2006 and on that basis Shanan and Brot Allowance will be worked out. It is made clear that single stage increment at a rate higher than normal annual increment which steps up the pay to a level more than normal rate of one increment as defined in master scale, will not be regarded as one increment for the purpose of this order.
2. This order shall take effect from 20.6.2006.
