





The Punjab State Electricity Board is pleased to make the following amendments in the existing Generation Incentive Scheme for entire period of shut-down of Units undergoing major R&M Works and also on completion of R&M Works for GNDTP Bathinda with immediate effect:-

- a) The entire period of revamping of a unit under R&M scheme shall be excluded for the purpose of computing Operating Plant Utilization Factor (OPUF).
- b) The outage period of both the units shall be excluded in case any other unit is under Annual/Capital overhaul for 30/60 days in parallel to the unit under revamping. The targets of daily generation/ PLH generation / Monthly OPUF during and after R&M of the unit shall be applicable as detailed in the table below:







Subject:- Merger of 50% of Dearness Allowance/Dearness Relief with basic pay/pension to government employees/pensioners w.e.f. 1.4.2004.

The Punjab Govt. vide its Notification No. 3/2/97-FP.1/4035 dated 1.6.2004 (copy enclosed) have decided to merge 50% of Dearness Allowance/Dearness Relief in the pay/pension w.e.f. 1.4.2004. The PSEB have decided to adopt this notification. It has been decided that whereas the decision taken by the Punjab Govt. as contained in the enclosed notification, will be followed in PSEB in toto, the following allowances admissible to Board employees will not be effected with the merger of 50% Dearness Allowance :-

- i) Shanar/Brot Allowance & Hill Compensatory Allowance.
- ii) Local Cut-door Duty Allowance/LODA.
- iii) Electricity Concession.
- iv) Generation Incentive.
- v) Hot Line Allowance.

Consequent upon the merger of 50% DA/DR into pay/pension, Dearness Allowance/Dearness Relief from 1.4.2004 would be payable @ 11% of pay + Dearness Pay/Pension + Dearness Pension. It is also in accordance with the decision taken by the Punjab Govt. contained in its Notification No. 3/2/97-FP.1/4125 dated 7.6.2004 (copy enclosed)

Subject: Merger of 50% Dearness Allowance/Dearness Relief with basic pay/pension to Government employees/pensioners w.e.f. 1.4.2004.

I am directed to invite your attention to the subject noted above and to say that following decision of Government of India in this regard the matter regarding merger of Dearness Allowance/Dearness Relief equal to 50% of pay with basic pay/pension in case of Punjab Government employees/pensioners has been under consideration of the State Government. The Governor of Punjab is pleased to decide that w.e.f. 1.4.2004 Dearness Allowance equal to 50% of existing pay shall be converted into Dearness Pay, which shall count as pay for the purpose of all allowances, retirement benefits, contribution to GPF and license fee. It shall not count for transfer grant which is presently not admissible in the case of Punjab Government employees and advanced entitlements for LTC, TA/DA while on tour etc. and Government accommodation which shall continue to be governed on the basis of basic pay alone without taking into account Dearness pay. In case of existing pensioners, Dearness Allowance/Dearness Relief equal to 50% of the present pension shall w.e.f. 1.4.2004 be merged with pension and shown distinctly as Dearness Pension. The Dearness Pension shall be taken into consideration for old Age Allowance but not for travelling concession admissible after every two years. Dearness Allowance/Dearness Relief converted into Dearness Pay/Dearness Pension respectively would be deducted from the existing rates of Dearness Allowance/Dearness relief.

2.- To ensure that pensioners retiring between 1.4.2004 to 31.1.2005 do not face any loss in fixation of pension, as a special dispensation in their case, DA equal to 50% of the basic pay shall be received by them prior to 1.4.2004. Consequently element of Dearness Pension will exist only for pensioners retired/retiring from Government of Punjab upto 31.3.2004.

3.- Amounts becoming due to serving employees during the period 1.4.2004 to 30.6.2004 shall be credited to their GPF accounts. Payments due w.e.f. 1.7.2004 shall be made in cash. Amounts due to pensioners shall, however, be paid in cash.

I am directed to refer to this Department letter No. 3/2/97-FP-1/2663 dated 24th March, 2004 on the subject cited above and to say that consequent upon the orders dt. 1.6.2004 circulated vide No. 3/2/97-FP-1/4035 of Merger of 50% Dearness Allowance/Dearness Relief into pay/pension w.e.f. 1.4.2004, Dearness Allowance from 1.4.2004 would be payable at the rate of 11% of Dearness Pay/Pension/Dearness Pension.

2.- The amount becoming due to the serving employees during the period from 1.4.2004 to 30.6.2004 shall be credited to their G.P.F. accounts. Payments due w.e.f. 1.7.2004 shall be made in cash. Amounts due to pensioners shall, however, be paid in cash.
