





Subject: Grant of Dearness Relief to the Pensioners/Family Pensioners of the Government of Punjab – Revised rates effective from 1st. July, 2005.

Sir/Madam

I am directed to refer to this Department Letter No. 1/29/98-3FPPC/4196, dated the 6<sup>th</sup> May, 2005 on the subject cited above and to say that the Governor of Punjab is pleased to decide that the dearness relief payable to Punjab Government Pensioners/Family Pensioners/Extraordinary Pensioners etc. shall be enhanced from existing rate of 17% to 21% with effect from 1st. July, 2005 to compensate them for the rise of cost of living.

1.2 Payment of dearness Relief involving fraction of a rupee shall be rounded off to the next higher rupee.

1.3 Other provisions governing grant of Dearness Relief to Pensioners etc. such as regulation of Dearness Relief during employment/re-employment and regulation of Dearness Relief where more than one pension is drawn etc. will remain unchanged.

1.4 On the analogy of decision taken by the Government of India, it has been decided to dispense with the issue of ready reckoner along with the Dearness Relief Orders. It will now be the responsibility of Pension Disbursing Authority, including the nationalized banks etc. to calculate the quantum of dearness relief payable in each individual case.

1.5 All District Treasury Officers/Treasury Officers and Public Sector Banks are requested to arrange payment of Dearness Relief to Pensioners/Family Pensioners etc. on the basis of these orders immediately.

2. The expenditure involved will be debited to the head "2071-Pension and Other Retirement Benefits."

3. The liability in respect of pre 1st. November, 1966 service of the pensioners and their family pensioners shall be divisible amongst the successor States of the erstwhile State of Punjab i.e. Punjab, Haryana, Himachal Pradesh and Union Territory, Chandigarh, in Terms of the 14<sup>th</sup> Schedule of Punjab Reorganization Act, 1966.

silent on the issue whether the pay of the senior employee can be stepped up for a second time, in case he happens to draw less pay than his junior due to stepping up of pay of the later with reference to pay of persons further junior to him by applying the above said provisions.

2. The matter have been considered and it has been decided to adopt the policy laid down by the government of India, which is as follows:-

"The pay of senior "A" employee is stepped up with reference to the pay of his first junior "B" and at a later date, the pay of "B" is stepped up with reference to another junior "C". Consequent on the stepping up of pay of the junior "B" with reference to "C", the senior "A" may happen to draw lesser pay than his junior "B". In such cases, the pay of the senior "A" may again be stepped up at par with his junior "B" provided all the conditions under the general orders for stepping up of pay of "A" vis-a-vis "C" are fully satisfied."

3. It is further clarified that the benefit of stepping up of pay can be allowed to senior official second time, provided the anomaly has arisen with reference to the pay of the same junior, with reference to whom the pay of the senior was stepped up first time.

4. That above clarification may be brought to the notice of all concerned.






