ORDERFinance Circular  
No. 24 /1994.No. 463 /Fin-38/Vol.VIII Dated : 30/6 /1994.

In continuation of this office order No. 457/Fin./38/Vol.VIII dated 3-1-1994, the Punjab State Electricity Board on the pattern of Punjab Govt. is pleased to decide that the rates of Dearness Allowance payable to the employees of the Board shall stand modified with effect from 1st January, 1994 as follows :-

Date from which payable	Pay Range	Rates of Dearness Allowance per mensem
1st January, 1994	Basic pay upto Rs. 3,500 per mensem	104 per cent of pay.
	Basic pay above Rs. 3,500 per mensem and upto Rs. 6,000 per mensem	78 per cent of pay subject to minimum of Rs. 3640/- P.M.
	Basic Pay above Rs. 6,000 per mensem.	67 per cent of pay subject to a minimum of Rs. 4680/- P.M.

2. The 'Pay' for the purpose of these orders shall be the 'Pay' as defined in Reg. 2.45(i) of the Punjab State Electricity Board MSR, Volume-I, Part-I, which is commonly known as 'Basic Pay' Non-Practising Allowance and Stagnation increments in respect of employees drawing pay in the Revised Scales of pay as per Punjab State Electricity Board (Revised Pay) Reg., 1988. In the case of employees who have not opted for the revised scales of pay but continue to draw pay in the pre-revised scales of pay, the 'Pay' for the purpose of these orders will include, in addition to 'Basic Pay' the Dearness Allowance, Dearness Pay, Adhoc Dearness Allowance and Interim Relief (wherever allowed) appropriate to that pay admissible under orders in existence on the 1st January, 1988. In terms of Punjab Government Notification No. 3/157/FCD/5988 dated

11th July, 1990 ( published in Punjab Government Gazette (Extra-ordinary) dated the 31st July, 1990), the dearness allowance is not admissible on deputation allowance.

3. The payment on account of Dearness Allowance involving fraction of 50 paise or above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored.

4. These orders are also applicable to the work-charged employees.

5. These orders ~~will not~~<sup>be</sup> applicable to the staff paid from contingencies, casual labour, staff employed on daily wages and those working on piece-rate system. These orders will also not be applicable to those employed on contract basis except where Dearness Allowance is admissible in terms of their contract.

6. The amount of Dearness Allowance for the period from the 1st January, 1994 upto the 31st March, 1994 in respect of the Board employees shall be credited to their General Provident Fund Accounts, that is the Additional Dearness Allowance due for payment from the 1st January, 94 to the 31st March, 1994 would be drawn and credited in the General Provident Fund Accounts of the employees in July, 1994. Where any Board employee was, during the said period, not eligible to subscribe to the Provident Fund, the drawal of arrears of Dearness Allowance shall be deferred till the employee concerned becomes eligible to contribute to the Provident Fund and the Provident Fund Account is opened in his/her name. In such a case, as and when the Provident Fund Account is opened and the amount of Dearness Allowance is credited thereto, interest will accrue from the 1st June, 94. The Board employees who have retired or had closed their

General Provident Fund Accounts before the issue of this order or who might close their accounts by the time the arrears are drawn, shall be paid the arrears of Dearness Allowance in cash in July, 1994. The arrears of Dearness Allowance for the period 1-1-1994 to 31-3-1994 may be paid in cash to the work-charged employees after deducting the amount of E.P.F. as applicable under rules.

7. However, in so far as the payment of Dearness Allowance to the staff employed on 89 days temporary basis/ on adhoc basis is concerned, the D.D.Os. are advised to allow such employees to purchase National Saving Certificates with the Dearness Allowance amount deducted from their salaries or National Saving Certificates may be purchased by the Drawing and Disbursing Officer themselves on their behalf till such amount is not credited to their G.P.F. accounts for want of allotment of regular General Provident Fund Accounts numbers. If there exist similar cases prior to the issue of these instructions, those may also be treated likewise.

8. The payment of Dearness Allowance in cash to the employees shall commence with effect from the 1st April, 1994 payable in the same month. Ready Reckoner showing the amount of Dearness Allowance payable with effect from the 1st January, 1994 onwards in terms of these orders are appended (at Appendix I & II)



The Board vide Office Order No. 299/Fin/PRC-1988 dated 19.10.93 revised the existing master scale Rs. 750-20-950-25-1200-30-1560-40-2000-50-2400-60-2700-75-3000-100-4000-125-5000-150-5900-200-6700 to Rs. 750 with initial start of Rs. 770-30-950-35-1160-40-1320-45-1500-50-2000-60-2060-70-2550-75-3000-100-4000-125-5000-150-5900-200-6700-w.e.f. 1.11.1993. Thereafter the instructions for settling the anomalies of the senior employees with the junior arising out of implementation of the revised Master Scale were issued vide Memo No. 62523/63248/PRC-96/L-2 dated 31.3.94. There was no such provision of adopting the revised Master Scale.

The matter has been re-considered by the Board and it has been decided to grant an option to the employees for coming over to the revised Master Scale provided:

- i. No anomaly will be claimed by the senior employee with the junior-employee.
- ii. The option once exercised shall be first and final.

The option shall be exercised within a period of three months from the date of the issue of these instructions.


