**Sub: Const. of Maintenance Bay for 2X250MW, Stage-II, GHTP, Lehra Mohabbat on EPC Basis against Tender Enquiry no.1/GHTP/CD-I/685- Black listing and forfeiture of EMD.**

Please refer the technical part of your Bid which was opened on 23.8.2012 for construction of subject cited case.

The requisite documents regarding carrying out work of EOT crane which were not submitted along with the bid were subsequently submitted by you on 24.9.12 enabling your offer to be qualified for price bid.

The price bid was opened on 12.10.12. Meanwhile physical verification was got done to corroborate the documents supplied by you subsequently. On physical verification/appraisal of the works, executed by your firm regarding 100MT capacity EOT crane, it was observed that the documents furnished by you in support of having executed the above work, were found to be fake and forged.

In this regard you were requested vide this office memo no. 773/78 dt. 18.2.13 to attend a meeting in the office of the undersigned on 22.2.2013 at 11:00A.M. with all the supporting documents as proof of having executed similar nature of work. You did not report for this meeting.

Thereafter you were requested again to explain your position either in person or through representatives within a week vide this office memo no. 922 dt. 27.2.13. As no response was forthcoming from your side, higher authorities were informed accordingly.

PSPCL taking cognizance of facts as detailed above, decided to initiate proceedings for blacklisting your firm for three years and forfeiture of EMD.

In compliance to the above decision of PSPCL, 15 days notice was served upon you vide this office memo no. 2825 dt. 21.6.13 to present your case against black listing of your firms and forfeiture of EMD. You met the C.E./Thermal(D) on 5.7.13 but could not come up with any satisfactory explanation regarding submission of fake and forged documents in support of your claim.

Due to above facts and to comply with the decision of PSPCL, it has been decided as under:-

1. To black list your firm thereby suspending business dealings with PSPCL for a period of 3 years from the date of issue of this letter.
2. To forfeit your EMD amounting Rs. 10,00,000/- (Rs. Ten Lac only).

This issues with the approval of competent authority.


