

### 1) PROJECT INFORMATION

Punjab State Power Corporation Ltd. (PSPCL) had a Thermal Plant namely Guru Nanak Dev Thermal Plant (GNDTP) at Bathinda was permanently shut down w.e.f. 01.01.2018.

### 2) INTRODUCTION:-

Punjab State Power Corporation Ltd having its Regd. Office at The Mall, Patiala (herein after called PSPCL) shall allocate the large quantity of Stones that are lying at the various sites of GNDTP, Bathinda. These stones are of various sizes which were separated from the Coal before being crushed or fed to the GNDTP units. PSPCL thus invites Expression of Interest from the interested firms for sale of stone as detailed below.

The total availability of stone in MT is as under: -

**Note:** Stones picked from coal racks have been dumped in deep pits at various locations of GNDTP and are lying mixed with ash, so it is difficult to assess the exact quantity. But as per observation approximately 1 Lakh MT is expected.

**Period of allocation:** The period of allocation shall be from 01.04.2025 to 31.03.2026.




### **3) GENERAL TERMS AND CONDITIONS**

- i. If required, interested parties may visit the site on any working day with prior approval of PSPCL. Interested parties are requested to submit their detailed proposal in response to this EOI.
- ii. All expression of interest documents, upon submission by any applicant to this EOI shall become the property of PSPCL. PSPCL is not liable for any cost or compensation in relation to the consideration of this EOI.
