## 1) PROJECT INFORMATION

Punjab State Power Corporation Ltd. (PSPCL) had a Thermal Plant namely Guru Nanak Dev Thermal Plant (GNDTP) at Bathinda was permanently shut down w.e.f. 01.01.2018.

## 2) INTRODUCTION:-

Punjab State Power Corporation Ltd having its Regd. Office at The Mall, Patiala (herein after called PSPCL) shall allocate the pond ash from the ash dykes of the Guru Nanak Dev Thermal Plant (GNDTP) at Bathinda. PSPCL will receive request /offers for allocation of pond ash from the firms / the users and the firms/the users shall take lift pond ash from the designated delivery point in their own covered vehicles. The lifting, loading & transporting of the pond ash shall be done in the scope of the firms. The Pond ash evacuation system shall be operated & maintained by PSPCL.


## 3) GENERAL TERMS AND CONDITIONS
