TERMS & CONDITIONS:

- 1) Earnest Money @ 2% of tendered value subject to a minimum of Rs.5000/- and maximum of Rs 10 lac for Contractors and as per Pb. Govt. Notification no. 76/52/79-C.1(5)/8856 dated 04.11.2019 for Co-op. L&C Societies.
- 2) Completion period: 45 days from the date of issue of Allotment Order/LOI.
- 3) The detailed set of NIT specifications will be available in the office of Sr.XEN/Civil construction and Mtc, PSPCL, Patiala on payment of Rs. 590 /- (inc. GST), nonrefundable for each set in cash or through crossed demand draft in favour of Sr.XEN/Civil construction and Mtc, PSPCL, Patiala.
- 4) Tenders of such bidder who do not purchase the set of NIT specifications shall not be opened.
- 5) Earnest money only in the form of PSPCL cash receipt or crossed demand draft in favors of Sr.XEN/Civil construction and Mtc, PSPCL, Patiala, of any scheduled bank (except Canara Bank and Yes Bank) payable at Patiala must accompany the tenders in separate envelope.
- 6) Tenders without earnest money shall not be opened.
- 7) Tender documents shall be issued only to those tenderers who prima facie met the qualifying requirements. However issue of tender documents shall not automatically construe qualification of the tenders for allotment of work, which shall again be determined during bid evaluation.
- 8) PSPCL reserves the right to reject/accept any or all the bids received at its discretion without assigning any reason what so ever.
- 9) Tenders shall be valid for acceptance up to 120 days from the date of their opening.
- 10) Tenders received telegraphically/ through fax/ through telex/ through email/ through telephone or incomplete tenders shall not be accepted.
- 11) If the fixed day for tender opening happens to be a holiday, the tenders will be opened at same time on the next working day in the presence of contractors/societies or their representatives who so ever like to stay there.

- 13) The bidder should have a valid registration certificate issued by any State/Central Government Department/PSU with registration limit minimum up to the cost of work.
- 14) The bidder shall have EPF and ESIC registration No. (if applicable) from the concerned Authority.
- 15) The bidder shall have GST no.
- 16) The bidder shall have PAN.
- 17) The bidder should give under taking that DNIT is acceptable in toto.

Note: 1) It is informed that in case tender process is not completed due to any reason, no Corrigendum will be published in newspapers. Details regarding corrigendum may be seen on official PSPCL website www.pspcl.in.

2) If three or more number of eligible Co-op. L&C societies submitted their tenders, then the tenders of these societies shall only be opened and tenders of eligible contractors shall not be opened.

In case less than three eligible Co-op. L&C societies submitted their tenders, then the tenders of eligible contractors shall also be opened along with the tenders of eligible Co-op. L&C societies".
