TERMS & CONDITIONS:

- 1) Earnest Money Rs 12,600/-
- 2) Completion period: **1 year** from the date of issue of Allotment Order.
- 3) The detailed set of NIT specifications will be available in the office of Addl SE/Civil construction and Mtc, PSPCL, Patiala on payment of Rs. 1180 /- (inc. GST), nonrefundable for each set in cash or through crossed demand draft in favour of Addl SE/Civil construction and Mtc, PSPCL, Patiala.
- 4) Tenders of such bidder who do not purchase the set of NIT specifications shall not be opened.
- 5) Earnest money only in the form of PSPCL cash receipt or crossed demand draft in favours of Addl SE/Civil construction and Mtc, PSPCL, Patiala, of any scheduled bank (except Canara Bank and Yes Bank) payable at Patiala must accompany the tenders in separate envelope.
- 6) Tenders without earnest money shall not be opened.
- 7) Tender documents shall be issued only to those tenderers who prima facie met the qualifying requirements. However issue of tender documents shall not automatically construe qualification of the tenders for allotment of work, which shall again be determined during bid evaluation.
- 8) PSPCL reserves the right to reject/accept any or all the bids received at its discretion without assigning any reason what so ever.
- 9) Tenders shall be valid for acceptance up to 120 days from the date of their opening.
- 10) Tenders received telegraphically/ through fax/ through telex/ through email/ through telephone or incomplete tenders shall not be accepted.
- 11) If the fixed day for tender opening happens to be a holiday, the tenders will be opened at same time on the next working day in the presence of contractors/societies or their representatives who so ever like to stay there.

- 17) Rates are to be quoted on percentage basis (+, - or at par)
- 18) The % age to be quoted by the bidder must be inclusive of the GST and no further GST shall be paid.
- 19) It will be responsibility of bidder to comply with GST Act.
- 20) The bill shall be prepared by the bidder and shall submit the same
