TENDER DETAILS

SCOPE OF WORK:-

1. Repair and replacement of defective/obsolete parts, Supply, Testing and Commissioning of Passenger-cum-freight lift, Micro processor based, AC Variable Voltage, Variable Frequency (AC VVVF) Drive (Operating supply voltage 415 volt, 3 Phase, AC), 2000 Kgs. @ 0.50 Mtrs./Sec. Travel 56.30 Mtrs. (5 Floors, Total rise 62.0 Mtrs.), Geared traction placed directly above hoist way complete in all respects as per technical specifications and with 5 stops/ 5 openings, all on the same side.
2. The scope of work also involves the dismantlement of the existing defective / obsolete part Boiler Lift No.4 of M/s. KONE Elevators India Pvt. Ltd. make.
3. The Bidder will quote buy-back rate for old the existing defective / obsolete part Boiler Lift No.4 of M/s. KONE Elevators India Pvt. Ltd. make lift in the tender on 'as is where is' basis and value will be adjusted/ deducted from the cost of new system. Vendor may inspect these equipments, if required by him, before furnishing the bid.

TERMS AND CONDITIONS:

1. The firms may download tender specifications after paying the requisite tender document fee electronically i.e. Rs.1180/- (non-refundable) plus GST (as applicable) from PSPCL Website <https://eproc.punjab.gov.in>. Tenders of only those firms/contractor will be considered who are registered with GGSSTP/GHTP/NTPC or other such central government organizations for the jobs of Design, Manufacture, Supply, Erection, Testing and Commissioning of lifts. Those firms, whose performance against the works/contract executed/being executed at GGSSTP / GHTP/during last 7 year is found to be unsatisfactory (by the competent authority) will not be considered for registration.
2. **REGISTRATION WITH GHTP:** Tender of only those technically suitable firms/ contractors will be considered who are registered with GHTP for above job. The firms already registered with GHTP for this work shall need to seek fresh registration in light of change in prequalification conditions from the previous enquiry. Firms desirous of getting themselves registered may send their applications for registration to the undersigned along with following documents:-
 - i) Bidder should have a minimum of 5 years existence in design, manufacture or supply, installation, commissioning and testing of lifts of capacity up to at least 2000 Kg. in India. Bidder to furnish documentary proof of this.
 - ii) The Manufacturer shall be certified to ISO 9001. Copy of valid certificate needs to be attached.
 - iii) Bidder should have supplied / Erected at least 5 nos. Freight cum passenger lifts of capacity 2000Kg. or above in India during last 5 years. Bidder will supply customer list for these giving details of Purchasing agency, P.O. No./ date & contact address of the customer.

- iv) Bidder will furnish performance certificate from at least two nos. Govt./ Semi. Government organizations in India for lifts of capacity at least 2000 Kgs. working satisfactorily after commissioning during the last five years.
 - v) Bidder should have annual turn-over of at least 50 Lakhs per year for last three financial years and necessary documentation for this will be submitted.
 - vi) The bidder shall submit latest Bank solvency certificate of minimum value of Rs. 50 Lakhs issued by any scheduled bank after 01/04/2023.
 - vii) Firm need to have its sales after service network such that its Engineers could report at plant maximum within 24 hours on break down call and within four hours in case of emergency. The list of after sales service network along with contact details may be furnished.
 - viii) Proof of having GST number.
 - ix) The firm should submit copy of letter from concerned authority showing PAN No.
 - x) The firm should submit proof of having independent ESIC Code. The firm should submit proof of having insurance form ESIC or group insurance for all the workers employed by the firm at GHTP for erection / dismantlement / repair of boiler no-4 lift against this enquiry.
 - xi) The firm should submit proof of having independent EPF account number.
 - xii) The firm should submit an affidavit in original, duly attested by an Executive Magistrate / Notary to the effect that the firm had not been defaulter in respect of deposition of EPF to the concerned EPF Commissioner for the workers deployed against work orders placed by PSEB / PSPCL on it during the last five years. In any case, the responsibility for deposition of EPF of the workers engaged by the firm shall rest with the firm only. In case, it is found defaulter at any stage, the contract shall be cancelled without any notice.
 - xiii) The firm should not have been blacklisted by any Government / Public Sector Power Utility during last five years. A self-attested undertaking that the firm has not been blacklisted by any govt. /public sector undertaking during the last five years.
 - xiv) Firm or its sister concern/ subsidiary is not in litigation with PSPCL. A self-attested undertaking to this effect will be given by the bidder.
 - xv) The application for registration must be accompanied with non-refundable registration fee of Rs. 1,000/- (Rs. One Thousand Only) plus GST as applicable (Present rate is 18%) Total Rs. 1180/- in the form of PSPCL Cash Receipt or Bank Draft in favor of AO/O&M, GHTP, Lehra Mohabbat payable at State Bank of India (IFSC Code No. SBIN0050840), GHTP, Lehra Mohabbat or at any other scheduled Bank payable at Rampura Phul, Distt.- Bathinda.
3. After registration the firm will become eligible for participating in tender and may purchase the tender documents by submitting fees of Rs. 1000/- Plus GST as applicable (Presently total Rs. 1180/- with GST @ 18% to be deposited electronically) on PSPCL website <https://eproc.punjab.gov.in>.
 4. The rates should be quoted as per reference performa.

5. Only tenders submitted in the mode described at Sr. No. 13 below shall be considered.
 6. **EARNEST MONEY:** All tenders must be accompanied by the Earnest Money at the rates prescribed in the tender documents except in case of those tenderers who are specifically exempted there-under. Tenders with insufficient earnest money shall not be considered/ accepted.
The tenderer (s) shall be required to deposit/transfer earnest money as per rules & regulations of the PSPCL.
 - a. The tenderer (s) shall be required to deposit/transfer fixed earnest money Rupees one Lakh only (Rs. 1,00,000/-) electronically on PSPCL website <https://eproc.punjab.gov.in>.
 - b. Public Sector undertakings fully owned by the Punjab Government/ Central Government/Other State Govt. shall be exempted from depositing Earnest Money, provided that a certificate of Government Ownership shall be submitted in the envelope for Earnest Money.
 - c. Earnest Money shall be forfeited in case of withdrawal/modification of an offer within the validity period, as required in the NIT/Tender Specification after opening of tender.
 - d. In case of successful tenders, Earnest Money shall be converted as Security Deposit.
 - e. In case of tenders not accepted/un-successful tenderer (s), the Earnest Money shall be refunded within 30 days of the award of order/contract to the successful tenderer (s) or after the expiry of additional period whichever is later.
 7. Conditional or incomplete tenders shall not be accepted.
 8. The rates should be quoted as per reference performa 'A' of Section-J of Tender specification The rates quoted must be valid for a period of at least 120 days from the date of opening of tenders.
 9. The rates quoted should be firm and inclusive of all levies, taxes (except GST). Applicability of GST may be mentioned clearly by the bidder.
 - (I) GST, if applicable, shall be payable extra by PSPCL against documentary proof of having deposited the same.
 - (II) Any extra /new taxes imposed after issue of tender enquiry shall be payable extra by PSPCL.
 10. **All tenders must be accompanied by the cost of tender specifications and Earnest Money at the rates prescribed in the tender documents as per Clause (1) of Section-H (General Terms and Conditions for Supply, Erection and Commissioning)** except in case of those tenders who are specifically exempted there-under. Tenders without cost of tender specifications and without or having insufficient earnest money shall not be considered /accepted. For any additional documents attached with techno-commercial bid, a hard copy must be submitted before the time of opening of techno commercial bid and certificate shall be submitted in this regard that no other document has been attached.
 11. The tenderers are required to estimate the quantum of work for which they should study for themselves and anticipate their commitments towards the work and quote their rates carefully taking into account all the probable contingencies.
- NOTE: - No other condition by the firm in this regard shall be acceptable.**
12. Tender received through e-mail or fax shall not be considered.
 13. **Tender evaluation shall be done on the basis of e-tendering followed by Reverse Auction** of item wise amount for all the items is/are the lowest.

14. PSPCL / GHTP, Lehra Mohabbat reserves the right to reject any or all offers without assigning any reason and no claim on this account will be accepted.
15. In case of any dispute regarding issue of tender documents or any other dispute, Chief Engineer/ O&M, GHTP, Lehra Mohabbat shall be the final authority and no claim on this account shall be accepted.
16. In case last date of registration, request for registration, bid opening date falls on a holiday, the next working day shall be applicable. Online bid submission date will not change.
17. In case of any dispute regarding this tender, General Manager/Chief Engineer, O&M/Chief Engineer, GHTP, Lehra Mohabbat shall be the final authority and no claim on this account shall be accepted.
18. **Tenders shall be signed by the owner or person holding power of attorney by him to do so. Necessary documents in support thereof should be enclosed with bid at the time of submission, failing which tender will not be considered.**
19. Bid should be submitted in three parts.
Part I: Tender document fee & Earnest Money Deposit.
Part II: Techno commercial Bid. (Through E-Tendering)
Part III: Price bid. (Through E-Tendering)
