4. Tenders of such bidders who do not purchase the set of specifications in advance shall not be opened.
5. PSPCL reserves the right to reject any or all the tenders without assigning any reason.

TERMS AND CONDITIONS:-

1. For the vehicles not more than 5 years old, work order shall be initially for a period of one year and the same shall be extendable on year to year basis for a further *period of three years, on the satisfactory performance of the vehicle/service provider* subject to condition that the vehicle can continue in the department upto the 7 years of its life. Hence the maximum period for which a vehicle can be hired is 4 years.
2. Only Commercial Vehicle with yellow number plate entry in Registration Certificate shall be hired.
3. If the contractor does not supply yellow number plate vehicle then his security will be forfeited and he will be black listed.
4. The vehicle should have valid RC, Insurance and Pollution certificate and the renewal of the same shall be the responsibility of the firm.
5. Vehicles shall be available for use round the clock, for utilization at our offices in Punjab, Chandigarh, Delhi and also for deputing to the neighboring States of Haryana, Himachal Pradesh, Rajasthan and J&K.

ELIGIBILITY CONDITIONS:

- i) Tenderer should not be blacklisted by any Govt./Public Sector Utility during last three years. A self-attested undertaking will be furnished by them in this regard.
- ii) Tenderer should have the vehicle registered on his/her/firm's name.
- iii) Photocopies of valid Driving License of Driver must be supplied.
- iv) Photocopy of the Insurance copy of vehicle must be supplied.
- v) Copy of valid PAN issued by Income tax department must be supplied.
- vi) Copy of GST registration must be supplied.
- vii) Copies of registration certificate of the vehicle must be supplied.
- viii) The firm should have independent EPF & ESI account no. issued from concerned department if applicable.
- ix) Tenderer should have minimum 2 no. Mohindra Bolero/TUV 300/Xylo or equivalent vehicle.
