**TERMS AND CONDITIONS**

1. A set of tender documents containing technical specifications, general instructions, terms & conditions can be obtained on any working day during office Hours up to date & time mentioned above on payment of amount as mentioned above for non-refundable tender cost per set by cash or by demand draft in favour of PSPCL or Senior Executive Engineer Civil Construction & Maintenance Division, PSPCL, Ludhiana.
2. The tender documents will be issued preferably to those Co-operative Labour & Const. Societies who are registered with Registrar / Assistant Registrar Co-op. Societies as given in the Schedule "A" above.
3. If the Co-operative Societies fail to purchase or submit the tenders on due date as per Schedule "A" above, then the tender documents will be issued to those contractors who have valid registration with PSPCL, Punjab Government, Central / State Government Undertakings etc.. The due date of issue, receipt and opening of tenders in respect of Contractors is given in Schedule 'B' mentioned above.
4. The Societies / Contractors should have registered EPF Number, Pan Number, GST Number and they will produce documentary proof thereof.
5. The Societies / Contractors will quote their % above /below or at Par with respect to

- departmental rates on the prescribed price bid prepared by this office. The percentage quoted by the contractor should be exclusive of GST.
6. The competent authority reserves the right to reject any or all the tenders received without assigning any reason what so ever.
  7. Conditional tenders and tenders received telegraphically / Fax / Telex and tenders which are not on the prescribed form issued by this office shall not be accepted.
  8. If due date of opening of the tender happened to be the holiday, the tender will be opened on next working day at the same time.
  9. Terms & conditions given in the schedule C (Section I to IV) of PSEB Work regulations 1997 with latest amendments shall be strictly adhered by the contractor. PSEB Works Regulations can be seen from Divisional Superintendent Accounts of this Division during any working day or can be downloaded from the PSPCL website.
  10. Tender of such bidders who will not purchase the set of NIT specifications shall not be opened. Also tenders without EMD (if applicable) shall not be opened.
  11. Tenders shall be valid for acceptance upto 120 days from the date of their acceptance.
  12. Rate should be quoted with overall percentage (+ -).
  13. Amount quoted shall be inclusive of GST. No GST shall be paid extra.
  14. The Tenderer shall comply with the GST act 2017.
  15. The contractor must comply with BOCW act 1996 ny other directions issued by competent authority without prejudice.
