3. QUALIFYING CRITERIA

- i) The bidder shall be original material/equipment manufacturer (OEM) / Authorized distributer/Dealer of OEM. Bidders quoting as authorized Distributors/Dealers of the OEM will be considered only after furnishing the manufacturer's Authorization Form (MAF) from the OEM.
- ii) The tenders of only those firms shall be considered who have supplied, similar material to Electric utilities/PSUs/SEBs/ Govt. organizations/Public sector Oil & Gas/Fertilizer Industry, reputed IPPs and Air Ports etc. Firms should submit copies of POs for having supplied material.
- iii) The value of POs is to be counted towards work experience shall be as under:
  - a.) Three similar complete orders each consisting not less than 2.40 Lac.
  - b.) Two similar complete orders each consisting not less than 3.0 Lac.
  - c.) One similar complete order consisting not less than 4.45 Lac.
- iv) The prospective bidder should have average annual financial turnover of Rs. 10 Lac or more during the last 3 years, ending 31st March of the previous financial year.
