- 4. The Societies / Contractors will quote their % above /below or at Par with respect to departmental rates on the prescribed price bid prepared by this office. The percentage quoted by the contractor should be exclusive of GST.
- 5. The competent authority reserves the right to reject any or all the tenders received without assigning any reason what so ever.
- Conditional tenders and tenders received telegraphically / Fax / Telex and tenders
 which are not on the prescribed form issued by this office shall not be accepted.
- If due date of opening of the tender happened to be the holiday, the tender will be opened on next working day at the same time.
