



## **PUBLIC NOTICE**

**For inviting comments and suggestions from the public and other stakeholders on Petition No. 37 of 2015 filed with Punjab State Electricity Regulatory Commission for approval of change of Regulation for Fuel Cost Adjustment Formula**

1. Notice is hereby given to all that Punjab State Power Corporation Limited (PSPCL) has filed a petition (Petition No. 37 of 2015) with Punjab State Electricity Regulatory Commission (PSERC) for approval of change of regulation for Fuel Cost Adjustment (FCA) formula. PSPCL in above said petition has proposed amendments in Regulation 55(1) & Appendix 7 of PSERC (Conduct of Business) Regulations, 2005 and also consequential amendments in Regulation 5 & Regulation 8(1) of PSERC (Terms and Conditions for Determination of Tariff) Regulations, 2005 and Regulation 50 of PSERC (Terms and Conditions for Determination of Generation, Transmission, Wheeling and Retail Supply Tariff) Regulations, 2014.
2. Petition No. 37 of 2015 along with comparison statement of Fuel and Power Purchase Price Adjustment formulae of five other State Electricity Regulatory Commissions prepared by PSPCL, in compliance to PSERC Order dated 05.08.2015 are available on the website of PSPCL i.e. [www.pspcl.in](http://www.pspcl.in) and can be downloaded there from.
3. Objections/comments on Petition No. 37 of 2015, together with supporting material may be filed with the Secretary, Punjab State Electricity Regulatory Commission, SCO 220-221, Sector-34-A, Chandigarh, in person or through Registered Post so as to reach him within 30 days of publication of this notice. Copy of the same must also be sent to Chief Engineer/ARR & TR, PSPCL, F-4, Shakti Vihar, Patiala and proof of service of the same must be enclosed with the filing made to Secretary, Punjab State Electricity Regulatory Commission.
4. The objections to the PSERC should be filed in ten copies and carry full name and postal address of the person sending the objection. If the objection is filed on behalf of any organization or any class of consumers, it should be so mentioned. It may also be specifically mentioned if the objector also wants to be heard in person.
