

**Subject: Regarding amendment in PSPCL Purchase Regulation, 2017 for implementation of Public Procurement (Preference to Make in Punjab) Order, 2019 in PSPCL-Amendment No.3.**

It has been decided by the Competent Authority to amend the Clause 28 (a) of Schedule E "Order Preference" of Purchase Regulations as under:-

Clause No.	Existing Clause	Amended Clause
28 of Schedule-E "Order Preference"	<p>PSPCL shall allow an order preference as per the procedure laid down as under to such bidders whose works are situated within the State of Punjab:-</p> <p>a) The rate of Punjab based firms shall be de-escalated by 15% for all the units (i.e. 100* Quoted Rates/115). For these firms quantity <b>upto 20%</b> of the total ordered quantity may be reserved provided their de-escalated rates fall below the lowest rates considered for the placement of purchase orders/ contract. For the purpose of allocation of quantity against Order Preference, the merit position of the Punjab based eligible firms shall be prepared separately. However, where the Punjab based firms qualify amongst the lowest bidders on their own quoted rates, they shall also form part of the original merit list without order preference for the purpose of allocation of quantity.</p>	<p>PSPCL shall allow an order preference as per the procedure laid down as under to such bidders whose works are situated within the State of Punjab:-</p> <p>a) The rate of Punjab based firms shall be de-escalated by 15% for all the units (i.e. 100* Quoted Rates/115). For these firms quantity <b>upto 50%</b> of the total ordered quantity may be reserved provided their de-escalated rates fall below the lowest rates considered for the placement of purchase orders/ contract. For the purpose of allocation of quantity against Order Preference, the merit position of the Punjab based eligible firms shall be prepared separately. However, where the Punjab based firms qualify amongst the lowest bidders on their own quoted rates, they shall also form part of the original merit list without order preference for the purpose of allocation of quantity.</p>

This amendment shall be applicable from the date of issue of these instructions for all tenders to be floated for procurement of material as per the Purchase Regulations- 2017, as amended.
